Alternative Revenue Recommendations

- Fire and Life Safety Inspection Fee Modification
- Special Event, Temporary Assembly, After-Hour Inspections and Permit Fees
- Tent Inspection
- Crowd Control Manager Class Fee
- False Fire Alarm Fees



Fire and Life Safety Inspections

- Recommendations:
 - Increase the fees for larger facilities based on 25K square foot increments versus 50k
 - More equitable fee for larger facilities and businesses with multiple buildings
 - 2. **Allow for no charge** if no violations are found on the Initial Fire Inspection
 - 3. **No charge** for re-Inspection if all violations corrected
 - 4. A double inspection fee will be charged if violations are not correct upon re-inspection

Special Event Inspections

- \$150 per event
- Approximately 20 per year
- Fairs, Arts Festivals, other open outdoor events with large crowds



Temporary Assembly Occupancy

- Approximately 20 per year
- Outdoor or Indoor Assembly
- For concerts or other special events with a large crowd in an enclosed area

Fee	Occupancy
\$75	50-500
\$150	501-1000
\$250	>1000



After Hour Inspections

- \$180 per event to cover cost of overtime
- Comparable to building department fees
- ACFR Charges \$90 per hour
- For after hour inspection requests for special events
- Approximately 20 per year



Tent Fire and Life Safety Inspection

- \$75 fee
- High hazard sales or enclosed areas
- Fireworks Sale
- Christmas Tree Sales



Crowd Manager Training

- \$30 per person
- Training is required by the FFPC
- Schedule 4 classes per year, providing training for approximately 300 crowd managers
- Training is offered through the internet and through other agencies for between \$25 to \$50 per person

False Alarm Fees

- Current fee structure does not cover cost of response
- Does not discourage owners to reduce incidents
- Does not encourage owners to correct deficiencies
