8	WHEREAS, notice was given as required by law that the text of the Code of Ordinances		
9	of the City of Gainesville, Florida, be amended; and		
10	WHEREAS, the City Plan Board, which acts as the local planning agency pursuant to		
11	Section 163.3174, Florida Statutes, held a public hearing on September 25, 2014, and voted to		
12	recommend that the City Commission approve this ordinance; and		
13	WHEREAS, an advertisement no less than two columns wide by 10 inches long was		
14	placed in a newspaper of general circulation and provided the public with at least seven (7) days'		
15	advance notice of this ordinance's first public hearing to be held by the City Commission in the		
16	City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and		
17	WHEREAS, a second advertisement no less than two columns wide by 10 inches long		
18	was placed in the aforesaid newspaper and provided the public with at least five (5) days'		
19	advance notice of this ordinance's second public hearing to be held by the City Commission in		
20	the City Hall Auditorium, located on the first floor of City Hall in the City of Gainesville; and		
21	WHEREAS, public hearings were held pursuant to the notice described above at which		
22	hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.		
23	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE		
24	CITY OF GAINESVILLE, FLORIDA:

If any word, phrase, clause, paragraph, section or provision of this ordinance or the application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall not affect the other provisions or applications of this ordinance that can be given effect without the invalid or unconstitutional provision or application, and to this end the provisions of this ordinance are declared severable.

Section 4. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict hereby repealed.
