

**ORDINANCE NO. 080203**  
**0-08-51**

AN ORDINANCE AMENDING APPENDIX A, SECTION UTILITIES (4) SEWERAGE OF THE GAINESVILLE CODE OF ORDINANCES BY INCREASING WASTEWATER BASE RATES AND CUSTOMER SERVICE CHARGES; IMPLEMENTING RECLAIMED WATER USAGE BILLING; INCREASING CONNECTION AND INSPECTION CHARGES AND TAPPING FEES; PROVIDING A REPEALING CLAUSE; PROVIDING DIRECTIONS TO THE CODIFIER; PROVIDING A SEVERABILITY CLAUSE; AND, PROVIDING AN EFFECTIVE DATE IN ACCORDANCE WITH THE SCHEDULE PROVIDED HEREIN.

**WHEREAS**, at least ten (10) days notice has been given of the public hearings once by publication in a newspaper of general circulation notifying the public of this proposed ordinance and of the public hearings in the City Commission meeting room, first floor, City Hall, City of Gainesville; and

**WHEREAS**, the public hearings were held pursuant to the published notices described above at which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:**

**Section 1.** Appendix A, Section Utilities (4) Sewerage of the Gainesville Code of Ordinances is hereby amended to read as follows:

(4) Sewerage:

a. Reserved.

b. Reserved.

c. Rates for normal strength wastewater (§ 27-169):

1. Residential dwellings, (including single-family dwellings, mobile homes, apartments, and residential customers on metered private wells):

(i) Charges for winter months (January and February billing periods):

(A) Customer service charge per bill rendered, per month..... ~~\$4.00~~\$6.00

17	but are subject to rates and charges under section 27-169(c), per month .....	<u>\$27.1530.70</u>
18	3. Single-family dwellings on private wells discharging unmetered water to the

22	system (does not include the customer service charge):

32	7. Where monthly wastewater service charges for nonresidential customers are based on the	
33	amount of the monthly water billed from the city, separate meters may be allowed at the	
34	expense of the customer and an allowance may be made for measured water not entering	
35	the city's wastewater system.

- 1 8. Where wastewater meters are required by the city or requested by the customer, the  
2 customer shall pay to the city a monthly charge based on the cost to the city of all operation  
3 and maintenance costs of the meter or meter installation plus depreciation. The initial cost of  
4 any and all such installations shall be paid for by the user.
- 5 9. The general manager for utilities or his/her designee is authorized to adjust residential  
6 monthly wastewater service charges to reflect reduced wastewater discharges from approved  
7 individual graywater disposal systems, as determined by procedures and engineering  
8 calculations contained in policies approved by the city commission.
- 9 d. Rates for excess strength wastewater (§ 27-169):
- 10 1. A customer discharging excess strength wastewater into the city's wastewater system shall  
11 be assessed a laboratory charge based on the cost of collecting and analyzing samples used  
12 to determine the strength and characteristics of the waste.
- 13 2. Where automatic sampling equipment is required by the city or requested by the customer  
14 and such equipment is owned and/or maintained by the city, a monthly sampling charge shall  
15 be assessed based on the cost to the city of operation and maintenance of the equipment  
16 plus depreciation.
- 17 3. A customer discharging excess strength waste into the wastewater system shall be assessed  
18 normal strength wastewater charges in addition to excess strength charges calculated  
19 according to the following formula:

$$[Y/X - 1] \times [Z] \times [0.5 \times A]$$
- 21 Y = Measured concentration of wastewater constituent.
- 22 X = Concentration of constituent in normal strength wastewater.
- 23 Z = Thousands of gallons of excess strength wastewater discharge into  
24 the city's wastewater system.
- 25 A = Normal strength wastewater rate per thousand in c.5(i) above.
- 26 Note: Excess strength charges shall be applicable only to the following conventional  
27 constituents: COD, BOD, total suspended solids, nitrogen and phosphorus. When COD is  
28 indicative of the excess wastewater strength, it shall be the preferred measurement  
29 parameter. Where the wastewater contains no more than one excess strength constituent,  
30 the charge shall be based on the constituent which results in the greatest charge.
- 31 e. Rates for septic tank and portable toilet waste (§ 27-169): Septic tank and portable toilet waste  
32 shall not be introduced into the city's wastewater system, except when specifically authorized  
33 and only at the time, place and manner prescribed by the city. This wastewater shall be metered  
34 and excess strength wastewater charges and industrial user charges shall be assessed.
- 35 f. Rates for industrial charges (§ 27-169): Any industrial user discharging into the  
36 City's wastewater system shall be assessed a permit application fee for each five-year

- 2 g. Right to assess other fees (§ 27-173): The city reserves the right to assess consumers  
3 other fees as necessary to carry out the requirements contained within article IV of  
4 Chapter 27. These fees relate solely to the matters covered by such article, and are  
5 separate from all other fees chargeable by the city.

- 6 h. Rates for reclaimed water service (§ 27-169):

7 1. Customer service charge per bill rendered, per month..... \$6.00

8 2. Rate per 1,000 gallons of reclaimed water metered..... \$0.60

9 1. Rate for unlimited use, per month, per bill rendered..... \$ 10.00

- 10 i. Wastewater flow-based connection charges (§ 27-171):

- 11 1. For two (2) inches and smaller water meters. For applicants of wastewater service requiring  
12 water meters up to and including two-inch meter size, the wastewater flow-based connection  
13 charge shall be based on the size(s) of the water meter(s) installed according to the following:

4. For customers discharging excess strength wastewater. In addition to wastewater flow-based connection charges assessed pursuant to subsection (i) of (ii) above, customers discharging excess strength wastewater into the city's wastewater system shall be assessed excess strength flow-based treatment plant connection charges calculated according to the following formula:

$$[Y/X - 1] \times A$$

Y = Measured concentration of wastewater constituent.

X = Concentration of constituent in normal strength wastewater.

A = Wastewater flow-based treatment plant connection charge assessed pursuant to subsection (i) or (ii) above.

- j. Inspection service fee (§ 27-172) ..... ~~\$ 1,015.00~~ 1,046.44
- Plus, an amount to be assessed on the amount of developer installed mainline collection piping, per linear foot..... ~~\$ 4.58~~ 4.72
- k. Off-site force main extension (CIAC) (§ 27-174): To be determined by the city.
- l. Requirement for additional CIAC (§ 27-175): To be determined by the city.
- m. Permit for construction of private sewerage disposal system (§ 27-183.1)..... \$ 5.00

**Section 2.** It is the intention of the City Commission that the provisions of Section 1 of this Ordinance shall become and be made a part of the Code of

Ordinances of the City of Gainesville, Florida, and that the Sections and Paragraphs of this Ordinance may be renumbered or relettered in order to accomplish such intentions.

**Section 3.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of such conflict hereby repealed.

**Section 4.** If any word, phrase, clause, paragraph, section or provision of this ordinance or the application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall not affect the other provisions or applications of the ordinance which can be given effect without the invalid or unconstitutional provisions or application, and to this end the provisions of this ordinance are declared severable.

**Section 5.** This ordinance shall take effect immediately upon its adoption; provided however, the rates and charges as provided for herein shall be applicable to all monthly bills which are for the first time rendered and postmarked after 12:01 A.M., October 1, 2008.
