Local funds will be transferred to SW 62nd Boulevard / 4 Lane Connection under Financial Project Number 211365-7-43-01 for Right of Way phase.

The remaining local funds for Depot Avenue Improvements were pledged by the CITY as matched local funds under statutory percentage 50/50%, as outlined in Section 339.2817, Florida Statutes for the County Incentive Grant Project Agreement / Depot Avenue Improvements under Financial Program Number 426044-1-58-01.

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made and entered into this ___ day of _____, 2017 by and between the FLORIDA DEPARTMENT OF TRANSPORTATION, hereinafter referred to as the DEPARTMENT and the CITY OF GAINESVILLE, hereinafter referred to as the CITY.

WITNESSETH

WHEREAS, the DEPARTMENT and CITY desire to transfer local funds remaining on Depot Avenue Right of Way Locally Funded Agreement (LFA) / Financial Project Number 420537-3-43-01 and 420537-4-4B,41,43-01.

WHEREAS, LFA funds were pledged by the CITY as matched local funds under statutory percentage 50/50%, as outlined in Section 339.2817, Florida Statutes for the County Incentive Grant Project Agreement / Financial Program Number 426044-1-58-0. The total local funds matched by the CITY include the LFA in the amount of \$2,091,022.00 and local dedicated construction funds in the amount of \$1,713,972.00 totaling \$3,804,994.00

WHEREAS, upon final acquisition or relocation of property under Depot Avenue Right of Way Locally Funded Agreement (LFA) / Financial Project Number 420537-3-43-01 and 420537-4-4B,41,43-01 local funds in the amount of Four Hundred Forty Three Thousand, Seven Hundred Dollars and 27 cents (\$443,700.27) which were used as local 50% match on the County Incentive Grant Project Agreement remain on Locally Funded agreement.

WHEREAS, the City elects to transfer the remaining local funds from Depot Avenue Right of Way Locally Funded Agreement (LFA) / Financial Project Number 420537-3-43-01 and 420537-4-4B,41,43-01 to the CITY's Local Agency Program (LAP) Agreement / SW 62nd Boulevard / 4 Lane Connection under Financial Project Number 211365-7-43-01. Local funds may be used interchangeably between design or right of way activities in support of the project.

WHEREAS, the DEPARTMENT and CITY recognize that a formal Memorandum of Agreement defining the financial duties and responsibilities of all parties is in the best interest of the DEPARTMENT and CITY.
