# DISCUSSION OF PENDING REFERRALS

#### 031225 Special Area Plan for Ironwood Area (NB)

John Wachtel, Neighborhood Planning Coordinator, gave an update on the Neighborhood Action Plan for Ironwood, which included beautification along Northeast 15th Street, and a wrought-iron fence at the entrance to the subdivision.

Mr. Harrington, President of the Golf Course Village Homeowner Association, stated that they appreciate all the help that the City provided to beautify the area. He asked that the City research who owns the empty building next to the gas station. He cited concerns that it might become a hazard.

Carol Barron, representing the Neighborhood Housing Development Corporation

(NHDC) gave an update on Northpoint at Ironwood, a new residential development. She stated that the value of the properties was increasing in the northeast area. She explained that NHDC would be developing 24 lots, and three builders had already purchased 13 of those lots. She stated that there were five homes under construction at the present time, and every home was a green home that would have a green builder certification. She indicated that prices ranged from \$129,000 - \$142,500, however, a price increase of 5 to 10% was expected with the next phase. She noted that a model home would be available within five months. She explained that she was working with the University of Florida on possible development of a rain garden that would be a model for the university teaching project.
