University Avenue and 13 Northeast 13th Street; providing a severability clause; providing a repealing clause; and providing an effective date.

WHEREAS, publication of notice of a public hearing was given that the Future Land Use
Map be amended by changing the land use category of certain property from the land use category of
Residential Medium-Density (8-30 units per acre)" to "Mixed-Use Low-Intensity (8-30 units per

- WHEREAS, notice was given and publication made as required by law and a public hearing was held by the City Plan Board on January 27, 2011; and
- 20 **WHEREAS**, the amendment to the land use category of the City of Gainesville 2000-2010 21 Comprehensive Plan proposed herein directly relates to a small scale development activity as provided

- WHEREAS, the City of Gainesville will transmit copies of the public notice and this proposed ordinance to the State Land Planning Agency, the regional planning council, and any other person or entity who has requested a copy; and
- WHEREAS, at least ten (10) days notice has been given of a public hearing once by publication in a newspaper of general circulation notifying the public of this proposed ordinance and of

3	WHEREAS, pursuant to law, notice has also been given by mail to the owner whose property
4	will be regulated by the adoption of this Ordinance, at least ten days prior to the date set for a public

6	WHEREAS, the public hearing was held pursuant to the published notice described above a
7	which hearing the parties in interest and all others had an opportunity to be and were, in fact, heard.
