

RESOLUTION NO. 051226  
 PASSED 5/8/06

**A resolution of the City Commission of the City of Gainesville, Florida; amending Resolution 050425, approved September 26, 2005, for the purpose of reallocating fees paid for grave spaces and services at Evergreen Cemetery; providing a repealing clause; providing an effective date.**

**WHEREAS**, section 7-9 of the Code of Ordinances provides that prices for grave spaces and services in the Evergreen Cemetery will be adjusted periodically based on review and analysis of local market rates and that said rates will be adopted by resolution of the City Commission; and

**WHEREAS**, as part of the City's 2005-2006 budget process, on September 26, 2005 the City Commission approved Resolution 050425 which increased certain user fees by 5% (effective October 1, 2005); and

**WHEREAS**, on March 13, 2006 the City Commission voted to support the acquisition of additional acreage for Evergreen Cemetery; and

**WHEREAS**, the funding for acquisition of additional acreage will come from future lot sales that requires an amendment to the allocation of grave space sale prices.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:**

**Section 1.** Paragraph 1 of Section 1 of Resolution 050425, regarding Fee Increase, is amended to read as follows:

**Section 1. Fee-increase Fees.**

As of ~~October 1, 2005~~May 1, 2006, the prices for grave spaces and allocation of total price for grave spaces at the Evergreen Cemetery will be:

**Section 3.** The fees in Section 1 above will take effect on May 1, 2006. All other fees remain in effect until amended by subsequent action of the City Commission. To the degree of conflict this Resolution supersedes all previous resolutions adopted by the City Commission on the matter of cemetery fees.
