An ordinance amending the Zoning Map Atlas of the City of Gainesville, Florida, by rezoning approximately 44 acres of property generally located north of SW 18th Place, west of SW 38th Terrace, east of SW 40th Terrace, and south of SW 9th Place, as more specifically described in this ordinance, from the Alachua County zoning categories of Agriculture (A) and Multiple family, high density (R-3) to the City of Gainesville zoning categories of Conservation (CON) and Urban mixed-use district 2 (UMU-2); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.

WHEREAS, notice was given as required by law that the Zoning Map Atlas of the City of Gainesville, Florida, be amended by rezoning certain property from the Alachua County zoning categories of Agriculture (A) and Multiple family, high density (R-3) to the City of Gainesville zoning categories of Conservation (CON) and Urban mixed-use district 2 (UMU-2); and

WHEREAS, notice was given as required by law and a public hearing was held by the City Plan Board on August 23, 2012; and

WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches long was placed in a newspaper of general circulation and provided the public with at least seven (7) days advance notice of the first public hearing to be held in the City Hall Auditorium, First Floor, City Hall, City of Gainesville; and

WHEREAS, a second advertisement no less than two columns wide by 10 inches long was placed in the aforesaid newspaper and provided the public with at least five (5) days advance notice of the second public hearing; and

WHEREAS, the public hearings were held pursuant to the notices described above at which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard; and

1 .	WHEREAS, the City Commission finds that the rezoning of the property described	
2	herein will be consistent with the City of Gainesville Comprehensive Plan when City of	
3	Gainesville Ordinance No. 120303 becomes effective as provided therein.	
4	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE	
5	CITY OF GAINESVILLE, FLORIDA:	
6	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the	
7	following property from the Alachua County zoning categories of Agriculture (A) and Multiple	
8	family, high density (R-3) to the City of Gainesville zoning categories of Conservation (CON)	
9	and Urban mixed-use district 2 (UMU-2):	
10 11 12 13 14 15	The existing Alachua County zoning categories on the property are depicted on the map attached as Exhibit "A" and made a part hereof as if set forth in full. The new City of Gainesville zoning categories on the property are depicted on the map attached as Exhibit "B" and made a part hereof as if set forth in full. (Note: The line dividing the CON zoning from the UMU-2 zoning is a westerly extension of the northern right-of-way of SW 16 th Avenue.)	
17	Section 2. The City Manager is authorized and directed to make the necessary changes to	
18	the Zoning Map to comply with this ordinance.	
19	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance	
20	or the application hereof to any person or circumstance is held invalid or unconstitutional, such	
21	finding shall not affect the other provisions or applications of this ordinance that can be given	
22	effect without the invalid or unconstitutional provision or application, and to this end the	
23	provisions of this ordinance are declared severable.	
24	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of	
25	such conflict hereby repealed.	
26	Section 5. This ordinance shall become effective immediately upon final adoption;	
27	however, the rezoning shall not become effective until the amendment to the City of Gainesville	

Comprehensive Plan adopted by Ordinance No. 120303 becomes effective as provided therein.
