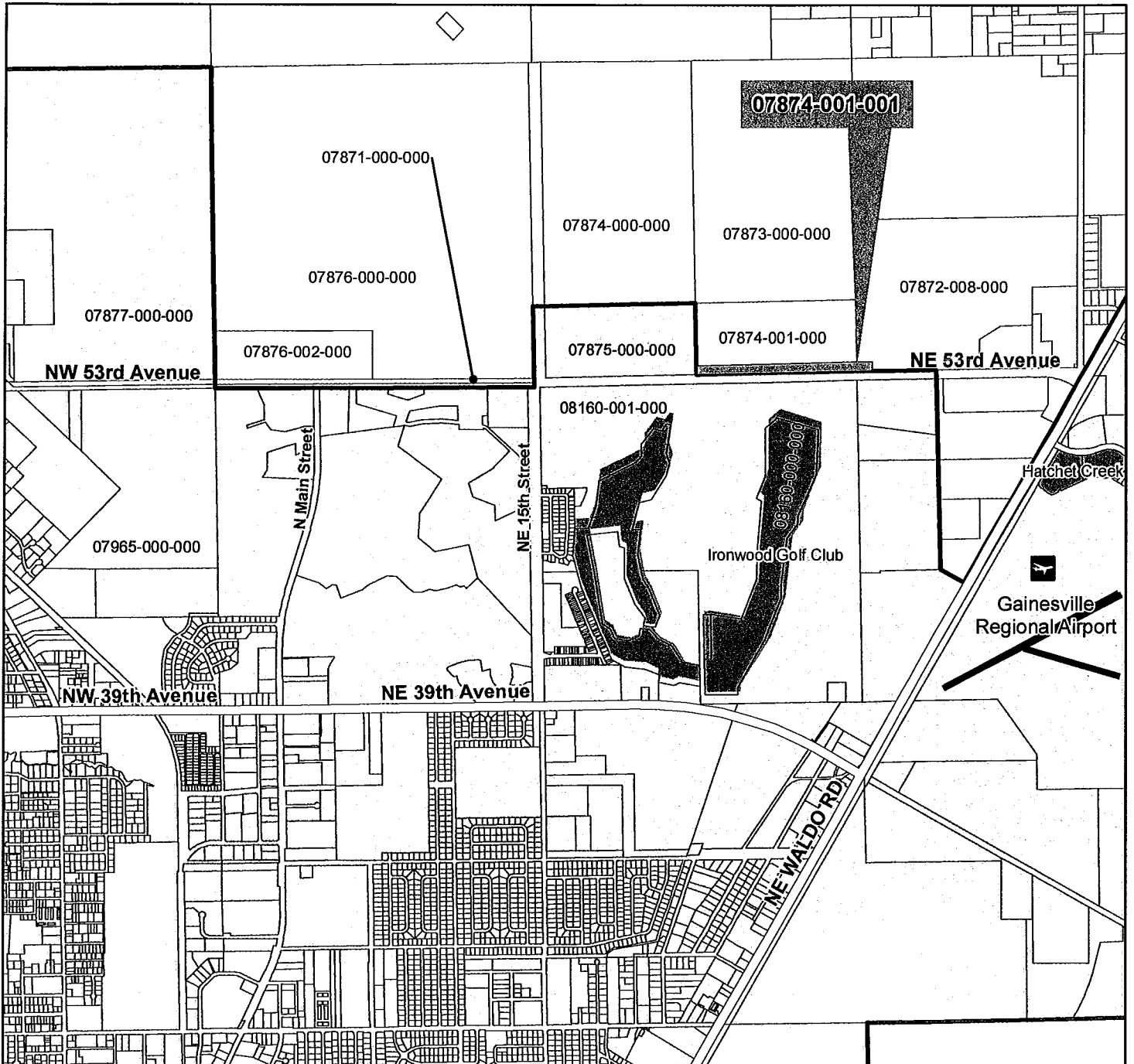

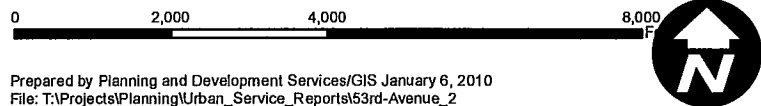

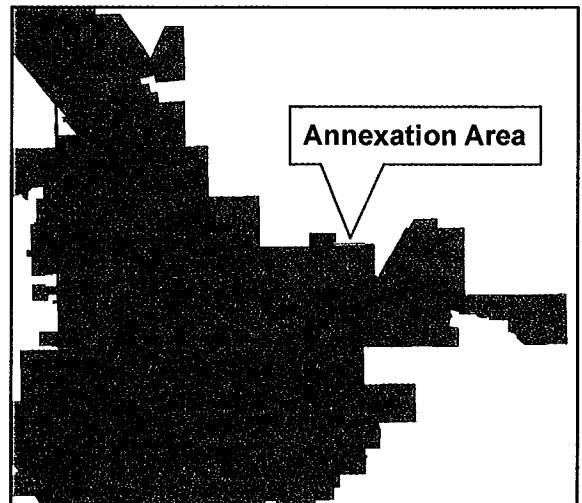


**Proposed Annexation of

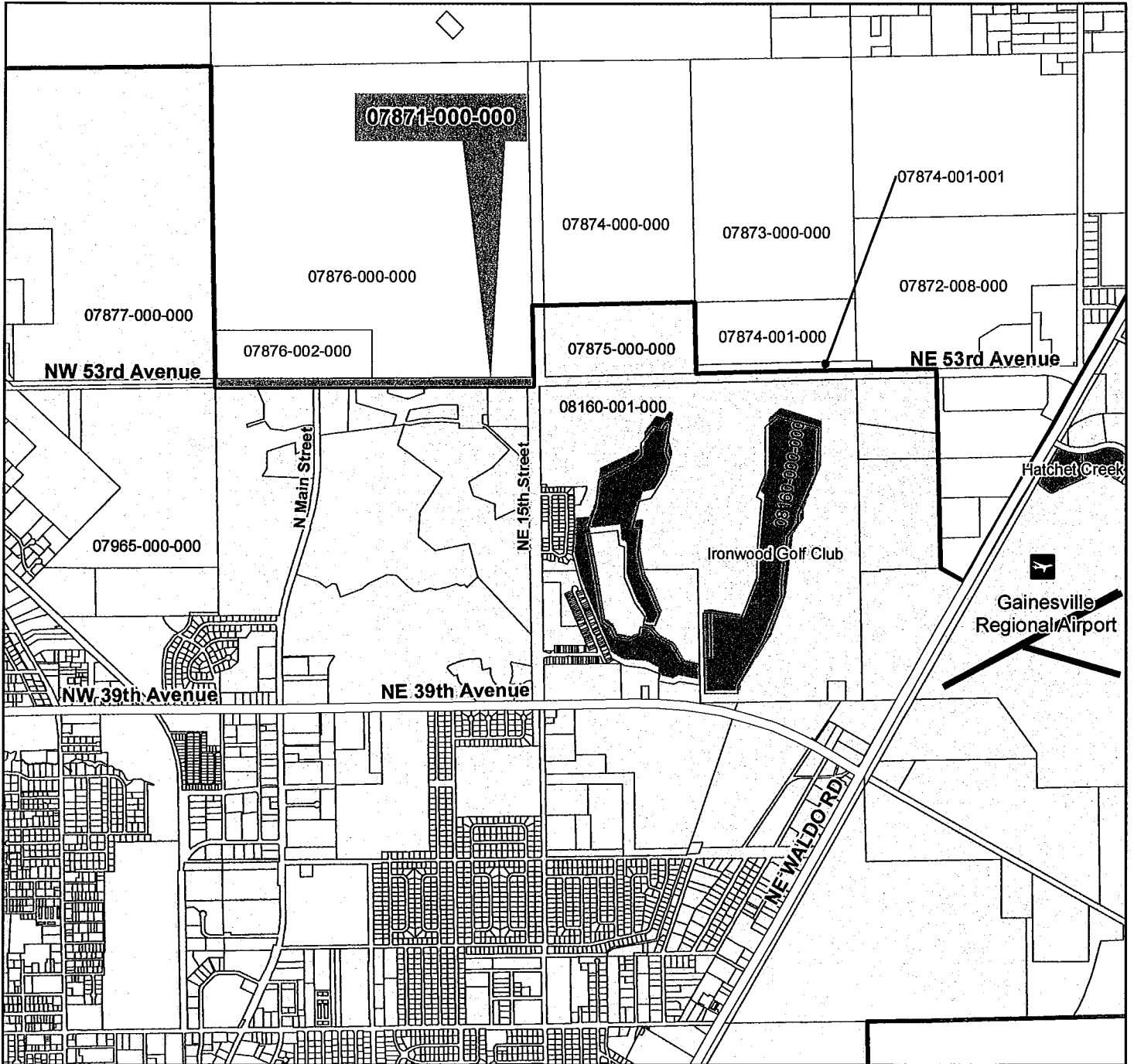

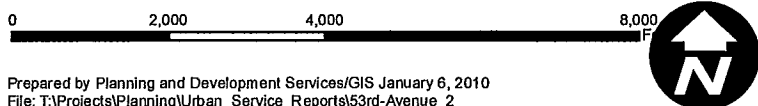
