17	WHEREAS, the Supervisor of Elections proposed changes to the Alachua
18	County voting precincts that were approved by the Board of County Commissioners;

20	WHEREAS, the above-referenced annexation and change in voting precincts
21	causes the City of Gainesville to amend the precinct numbers that comprise the three
21	causes the only of Camesvine to amend the predict numbers that comprise the tillee
22	election districts of the City of Gainesville; and
23	WHEREAS, at least 10 days notice has been given by publication in a
24	newspaper of general circulation notifying the public of this proposed ordinance and of

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE

1	Section 1. Chapter 9 of the Code of Ordinances of the City of Gainesville is
2	amended to read as follows:
3	Sec. 9-1.1. Election districts.
4	(a) In accordance with section 2.02 of the Charter of the city, the following election
5	districts are hereby established for the purpose of representation upon and election of
6	three members to the city commission:
7	District No. 1
8	District No. 1 shall be comprised of the following precincts: Precinct Nos. 13, 16
9	19, 23, 25, 28, 29 and 33, and 59.
10	District No. 2
11	District No. 2 shall be comprised of the following precincts: Precinct Nos. 7, 12,
12	17, part of 21, 27, 37, 38 and 45, <u>55, 57 and 58</u> .
13	District No. 3
14	District No. 3 shall be comprised of the following precincts: Precinct Nos. 4, 5,
15	part of 21, 24, 26, 31, 32 and 40, 44, 54, 61 and 64.
16	
17	A map identifying the election districts is attached to the ordinance from which this
18	section derives as Exhibit A for illustrative purposes only and is on file in the office of
19	the clerk of the commission.
20	(b) As used in this section, the term "precincts" means the county election precincts
21	of Alachua County, Florida, as recommended by the supervisor of elections and
22	approved by the board of county commissioners. The boundaries of said precincts are

section derives or any amendatory ordinance, but only to the extent that they are
