An Ordinance of the City of Gainesville, Florida, annexing a portion of the City of Gainesville Reserve Area Pursuant to Chapter 90-496, as amended, by Special Acts, Laws of Florida, known as the Alachua County Boundary Adjustment Act; making certain findings; including within the corporate limits of the City of Gainesville, Florida, that certain compact and contiguous area comprising approximately 128.20 acres (MOL) generally located north of NW 69th Lane and Blues Creek Unit-2, west of NW 52nd Terrace, NW 50th Street and the Blues Creek Subdivisions, south of the City limits, east of Section 9, Township 9S, Range 19E; providing for inclusion of the area in Appendix I of the City Charter; providing for land use plan and zoning regulations; providing for enforcement of Alachua County, land use plan, zoning and subdivision regulations; providing directions to the City Manager and Clerk of the Commission; providing a severability clause; and providing an immediate effective date.

WHEREAS, Chapter 90-496, Special Acts, Laws of Florida, as amended by Chapter 91-382 and Chapter 93-347, Special Acts, Laws of Florida, created the "Alachua County Boundary Adjustment Act" (hereinafter collectively referred to as "the Act") which sets forth procedures for the annexation of contiguous, compact, unincorporated territory within a municipality's reserve area; and

WHEREAS, on January 13, 1998, the Board of County Commissioners of Alachua County designated the Reserve Area for the City of Gainesville pursuant to the Act; and

WHEREAS, on June 21, 2000, the owner of the real property described herein submitted a Petition for Voluntary Annexation requesting the City to incorporate said property into the City of Gainesville; and

1	WHEREAS, on November 13, 2000, the City Commission voted to accept said Petition
2	and determined that the Petition bore the signatures of the owners of the property; and
3	WHEREAS, on January 22, 2000, the City Commission of the City of Gainesville adopted
4	Ordinance No. 000797, which adopted the Urban Services Report setting forth the plans to provide
5	urban services to that portion of the Reserve Area proposed to be annexed in accordance with the
6	procedures provided in the Act; and
7	WHEREAS, a copy of the Urban Services Report was filed with the Alachua County
8	Board of County Commissioners and the real property owner affected by this ordinance; and
9	WHEREAS, the City of Gainesville desires to annex a certain portion of its Reserve Area
10	which is compact and contiguous to the present corporate limits of the City; and
11	WHEREAS, pursuant to law, notice has been given by publication once a week for two
12	consecutive weeks in a newspaper of general circulation notifying the public of this proposed
13	Ordinance and of Public Hearings to be held in the City Commission meeting room, First Floor,
14	City Hall, in the City of Gainesville; and
15	WHEREAS, Public Hearings were held pursuant to the published notice described above at
16	which hearings the parties in interest and all others had an opportunity to be and were, in fact,
17	heard.
18	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
19	CITY OF GAINESVILLE, FLORIDA:
20	Section 1. The City Commission finds that the Area described in Section 2 of this
21	Ordinance (hereinafter referred to as the "Area") is reasonably compact and contiguous to the
22	present corporate limits of the City of Gainesville, and that no part of the Area is within the

- boundary of another municipality or county. The City Commission finds the Area to be within its
- 2 Reserve Area and the annexation does not create an enclave.
- 3 Section 2. The following described Area is annexed and incorporated within the corporate
- 4 limits of the City of Gainesville, Florida:
 - See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.

- Section 3. The corporate limits of the City of Gainesville, Florida, as set forth in Article 1,
- 9 Charter Laws of the City of Gainesville, are amended and revised to include the Area described in
- 10 Section 2 within the corporate limits of the City of Gainesville, Florida.
- Section 4. The City Manager is authorized and directed to make the necessary change to the
- legal description of the Municipal Corporate Limits as codified in Appendix 1 of the City Charter
- of the City of Gainesville, Florida, to comply with this ordinance.
 - Section 5. In accordance with Section 171.062, Florida Statutes, the Alachua County land use plan and zoning or subdivision regulations shall remain in full force and effect in the Area described in Section 2 of this Ordinance until the City adopts a comprehensive plan amendment that includes the annexed area. The Gainesville Code Enforcement Board and code enforcement officers shall have jurisdiction to enforce these regulations during the interim period through the Gainesville Code Enforcement Board process as described in Division 8 of Chapter 2 of the Code of Ordinances of the City of Gainesville. During the interim period, the City may rezone properties in the annexed area to an Alachua County Zoning classification/category that conforms with the Alachua County Comprehensive Plan.

) 1	l	Section 6. If any portion of this Ordinance is declared by a court of competent jurisdiction
2	2	to be invalid or unenforceable, such declaration shall not be deemed to affect the remaining

۷	1	Section 7. The Clerk of the Commission is directed to submit a certified copy of this
5	5	Ordinance to: 1) the Executive Office of the Governor; 2) the Florida Department of State; and 3)
6	6	the Clerk of the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida.
7	7	Section 8. This Ordinance shall become effective immediately upon adoption.
