CURRENT ACTION ITEMS

100008. Rebates/Incentives for Window Replacement (B)

Explanation: In July of 2006 staff began implementation of an aggressive Energy Efficiency Program. To date numerous programs have been implemented to help achieve maximum cost-effective energy efficiency. In May of 2010 the City Commission referred the item to the RUC to investigate the possibility of including an energy efficient window rebate program as part of the residential program offerings. Staff analyzed the window and window covering rebates using the Total Resource Cost (TRC) test to determine its cost effectiveness. Staff's recommendation is based on these results.

RECOMMENDATION

Hear a presentation from staff regarding a window and window film energy efficiency incentive. Staff would like to run a pilot program to start October 1, 2011 that would provide rebates for energy efficient windows and window film. If the pilot is successful, it could be rolled into our current portfolio of efficiency programs in FY 12. Staff also recommends this item be removed from the referral list.
