12 13	WHEREAS, pursuant to Section 30-192 of the Code of Ordinances of the City of
4	Gainesville, an application was initiated to vacate, abandon and close that portion of the alley
15	located between Southwest 13th Avenue and Southwest 14th Avenue between Southwest 13th Street
16	and Southwest 14th Street, as more specifically described herein, to make possible the Shands Cancer
17	Hospital development; and
18	WHEREAS, notice was given and publication made as required by law and a public
19	hearing was held by the City Plan Board on August 17, 2006; and
20	WHEREAS, at least ten (10) days notice has been given of the public hearing once by
21	publication in a newspaper of general circulation notifying the public of this proposed ordinance
22	and of the public hearings in the City Commission meeting room, First Floor, City Hall, in the City
23	of Gainesville; and
24	WHEREAS, notice has also been given by mail to all owners of property abutting the
25	portion to be vacated prior to the adoption of this ordinance; and
26	WHEREAS, prior to the public hearings the application was presented to and approved
27	by the appropriate Departments of the City; and

1	WHEREAS, the City Commission finds that it is in the public interest to vacate, abandon
2	and close the right-of-way as set forth herein to make possible the Shands Cancer Hospital
3	development, but that the right-of-way is otherwise required for public use and benefit if the
4	project is not constructed and completed; and
5	WHEREAS, the City Commission is willing to vacate, abandon and close the right-of-
6	way subject to specific terms and conditions in an enforceable agreement between the City and the
7	owner/developer, its successors and assigns.
8	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
9	CITY OF GAINESVILLE, FLORIDA:
10	Section 1. Except as provided in Sections 2 and 3 below, the following described right-
11	of-way in the City of Gainesville no longer serves a public purpose and is hereby vacated,
12	abandoned and closed for use by the public generally in order to make possible the project,
13	commonly known as "Shands Cancer Hospital":
14 15	See legal description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.
16	Section 2. The City reserves unto itself, its successors and assigns a public and private
17	utilities easement over, under, across and through the right-of-way described in Exhibit "A",
18	attached hereto and made a part hereof, for the purpose of operating, maintaining, removing and
19	relocating the public and private utilities located therein.
20	Section 3. The vacation, abandonment and closure of the right-of-way described in § 1
21	of this Ordiannce is subject to the terms and conditions of a certain Vacation of Right-of-Way

Southeastern Health Care Foundation, Inc., which Agreement provides, among other things, that

6	or unconstitutional by any court of competent jurisdiction, then said holding shall in no way	affect	
7	the validity of the remaining portions of this ordinance.		
8	Section 6. All ordinances, or parts of ordinances, in conflict herewith are to the ext	ent of	
9	such conflict hereby repealed.		
10	Section 7. This ordinance shall become effective immediately upon final adoption.
