MOTION: Mayor-Commissioner Pro Tem Lowe moved and Commissioner Donovan seconded to adopt the tentative proposed millage rate of 4.9250 and the FY 2007-2008 tentative proposed budget including the additional line items: 1) Include the transfer of seven positions from temporary to permanent in Nature Operations \$53,647; 2) addition of a downtown maintenance worker \$47,414; 3) addition of three (3) additional firefighters in order to reduce the overtime budget; 4) upgrade in GFR Hazmat \$20,000; 5) set aside \$20,000 for outside agencies and come back to the City Commission with a recommendation from P & O regarding a process for allocation of those funds; 6) Family Re-unification Program \$10,000; and 7) Homeless Services \$25,000.

(VOTE: 7-0, MOTION CARRIED)

NOTE: The City Commission referred the issue of outside agency funding to the Personnel and Organizational Structure (P & O) Committee for recommendations for a process of allocating funds to outside agencies. It was agreed upon by consensus to include this issue with (Referral Item #050167 "City Commission Contingency

Funding Allocation Policy") already in committee.
