Providing Broadband and Digital Inclusion in Housing Authorities (NB)

Motion: Direct staff to begin discussions with the Gainesville Housing Authority for broadband and digital inclusion.

Listed below are comments/suggestions from the Subcommittee:

Commissioner Hayes-Santos: 1) What other communities have done; 2) How can we spread digital inclusion with the Housing Authority (partnership); 3) How to make it much more useful than using a phone; and 4) How can we partner with the Library district.

Executive Director, Pamela Davis: 1) Use money to rehab properties and come back with an infrastructure (allowing to use CDBG funds, public housing funds); 2) Happy to partner with anyone; 3) Working with Tampa Housing Authority; 4) Redeveloping public housing sites in the community; and 5) A couple of sites have computer labs.

Chair Ward: 1) Lighting and infrastructure (general accessibility); 2) Interested in how the City can help get the technology into the housing units (who can we partner with).

Commissioner Simmons: 1) Would like to see information from Tampa and other Housing Authorities.

Maureen stated that they partnered with the Knight Foundation in Macon, Georgia
