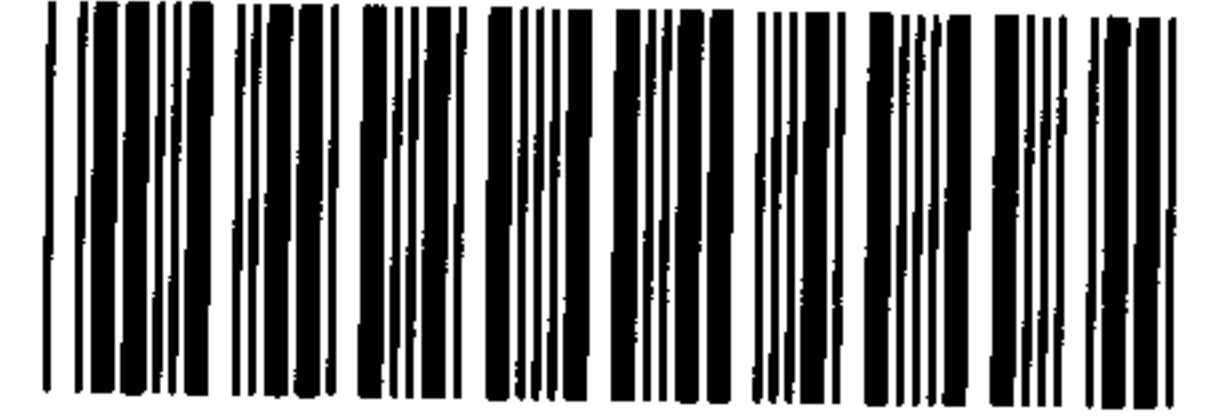

WITNESSETH: That Grantor, for and in consideration of the sum of \$1.00 in hand paid by the Grantee, receipt of which is hereby acknowledged, does hereby grant, bargain, sell, alien, remise, release, convey and confirm unto the Grantee, all that certain land situate and lying in the County of Alachua, State of Florida, to wit:

FOR A POINT OF REFERENCE COMMENCE AT THE NORTHEAST CORNER OF LOT 21 (AS MONUMENTED) OF "COLCLOUGH'S ADDITION TO THE CITY OF GAINESVILLE", AS PER PLAT THEREOF RECORDED IN PLAT BOOK "A", PAGE 20 OF THE PUBLIC RECORDS OF ALACHUA COUNTY, FLORIDA, THENCE RUN SOUTH 02 DEGREES 41 MINUTES 15 SECONDS EAST, ALONG THE EAST LINE OF SAID LOT 21, FOR 95.27 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE SOUTH 02 DEGREES 41 MINUTES 15 SECONDS EAST, ALONG SAID EAST LINE, FOR 62.70 FEET TO THE NORTH RIGHT OF WAY LINE OF SW DEPOT AVENUE; THENCE RUN SOUTH 76 DEGREES 26 MINUTES 25 SECONDS WEST, ALONG SAID NORTH RIGHT OF WAY LINE, FOR 112.38 FEET; THENCE RUN NORTH 02 DEGREES 43 MINUTES 07 SECONDS EAST, FOR 86.48 FEET; THENCE RUN NORTH 88 DEGREES 39 MINUTES 06 SECONDS EAST, FOR 110.44 FEET TO THE POINT OF BEGINNING.

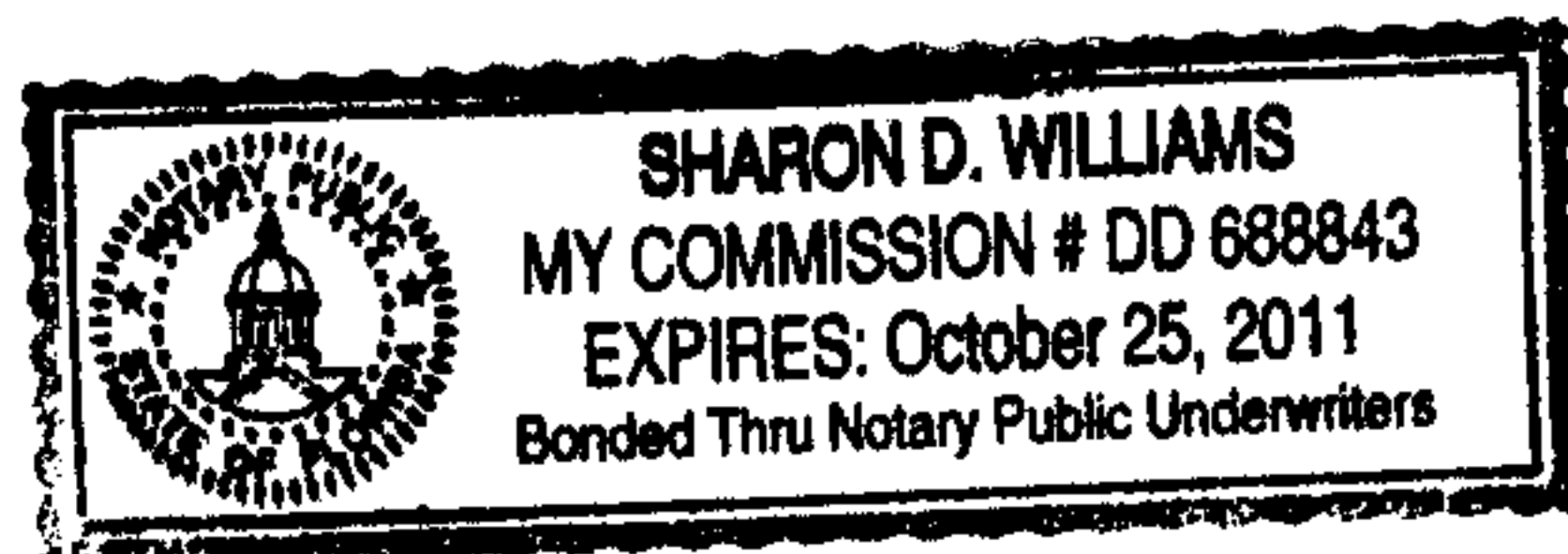
