#### **CURRENT ACTION ITEMS**

#### 100008. Rebates/Incentives for Window Replacement (B)

Explanation: In July of 2006 staff began implementation of an aggressive Energy Efficiency Program. To date numerous programs have been implemented to help achieve maximum cost-effective energy efficiency. Since 2006, programs have been modified based on customer participation rates and feedback, participation and feedback from partnering contractors and federal changes in efficiency standards. Included in this will be an explanation of how rebates are evaluated and the evaluation of windows.

**RECOMMENDATION** Staff will provide an update of GRU's conservation

strategies and progress to date; an explanation of the federal stimulus funds designated for weatherization; and an explanation of staff's evaluation of rebates for

the replacement of windows.
