### **120997.** Public Safety Committee Referral List Update (B)

RECOMMENDATION

The Public Safety Committee hear an update from staff on the Committee's pending referral list.

The Committee members voted 3-0 to request the City Commission remove four items from the Public Safety Committee's referral list, as recommend by staff.

The items to be removed are:

- 1) 120347 Special Event Permits for Bars On March 21, 2013 the City Commission Directed the City Attorney to prepare and the Clerk of Commission to advertise an ordinance to expand the extension of premises Citywide and allow up to 4 Special Event Permits per year providing extension of premises for alcohol above and beyond UF Football Home Games and to authorize the Plan Board Petition and first reading of the ordinance to occur at the same meeting.
- 2) 120206 Roam Towing and the Appeals Process This item was discussed by the full City Commission on December 20, 2012 and direction was given to staff to draft ordinance change for City Commission approval.
- 3) 120063 Request To Increase Trespass Towing Rates This item was discussed by the City Commission along with the referral on Roam Towing and the Appeals Process on December 20, 2012. The City Commission continued to consider an increase to trespass towing fees on April 18, 2013.
- 4) 110933 Special Events/Expanded Premises Permitting This item ties in with the Special Event Permits for Bars.

Staff will prepare an agenda item for a future City Commission Meeting requesting the removal of these items from the Committee's referral list.

### **MEMBER COMMENT**

Commissioner Chase asked for information on half-way houses in Gainesville; what resources are there to refer citizens to who are in need. GFR's Fire Assistant Chief Joanne Rice shared that many organizations do not set up official half-way houses due to the many regulations and permits required.

Commissioner Poe plans to request the City Commission create a resolution to support Florida Senator Rubio's initiative on mental health homes.
