Subject: **Comprehensive DUI and Underage Drinking Plan**

GPD staff has put together a one-year long program patterned after our previously successful Comprehensive Drug Plan to address DUI, underage drinking, and alcohol related crimes. Though many parts of the Plan are finalized, the full Plan is not completely funded with one grant application outstanding. Much work has been put into utilizing existing programs and personnel at GPD as well as adding components and partners to make the Plan comprehensive. Information below serves as brief overview.

**Comprehensive DUI & Underage Drinking Plan**

**Goal:** Reduction of crashes, injuries, & fatalities caused and/or related to driving while under the influence of alcohol or other drugs. Reduction in crimes related to underage drinking. Further develop community partnerships that reduce behaviors leading to DUI & underage drinking. Goals are addressed through components addressing prevention, education, awareness, intervention, treatment, and enforcement.

**Duration:** Late August, 2007 – August, 2008

**Partnerships:** Committed major partners are Shands, the State Division of Alcoholic Beverages and Tobacco (ABT), UF Department of Health, Education, & Behavior and UF Student Government. Other partners include the Gainesville Responsible Hospitality Partnership (GRHP), Partners in Prevention of Substance Abuse Coalition, Black on Black Crime Task Force, Santa Fe Community College (SFCC), public schools, and the Community Traffic Safety Team.

## IOC – GPD Comprehensive DUI and Underage Drinking Plan

### Components:


- Sobriety checkpoints focused on main thorough fares, traffic corridors, & locations that impaired drivers are likely to traverse.
- Saturation patrols & High Profile uniformed enforcement by uniformed officers focusing on specific areas of town with emphasis on traffic & alcohol violations enforcement
- Gators – Saints “SAFE-T Kiosk” primarily in University Park / Midtown bar district. SAFE-T = safe assistance and education team. Objective: Getting persons to a place of safety, providing bold messaging in the form of harder edged literature, ID wristbands, banners, etc. Staffed on active bar nights by GPD with UF Dept of Health, Education, & Behavior volunteers.
- Party patrol – Efforts continue to be focused on neighborhood based alcohol, noise, & open house party complaints with media attention, follow up on problem locations, and landlord resolution.
- Hospitality bar district training for alcohol establishments with ABT.
- Public school education via GPD School Resource Officers & yearbook ads designed by students for students.
- Spring Break Safety Fairs at both UF & SFCC.
- “Scared straight” type of program development for alcohol offenders. Shands Trauma Center Manager will work towards implementation in conjunction with courts.
- National Webinar hosted by GPD & the GRHP titled “Innovative Crime Prevention in Hospitality Districts” Sept 18, 1pm at GPD. Best practices forum online.
- “GPD Police Beat” episode focused almost exclusively on DUI & underage drinking.
- Extensive media & public information. Shands especially can provide public information with a medically based perspective.
- Additional equipment purchasing in the form of Kiosk literature, portable breath testing equipment, & in car cameras.

**Subject:** Responsibility Hospitality Partnership and Underage Drinking Violations

Attached is a spreadsheet listing forty-one locations that primarily serve alcohol, along with the current business name. The numbers listed were pulled from Pistol Records Management system using three months of data, from 10/01/07-12/31/07. The data was pulled by address. The Business name is the current name being used. Some business may have changed ownership, however. By using the address, the more problematic areas can be identified.

An explanation of the columns is as follows:

**“Business Name”** – The current Business name is farthest to the left in the column. (Some previous business names are also noted)

**“Location”** – The numerical address of the Business/Bar.

**“All Arrests”** – The total number of arrests covering all offenses for that location. The parameters used to obtain this data were from the arrest module, all arrest during the dates listed above, at the listed address.

**“Poss <21”** – The number of arrests for the charge of “possession of alcohol by a person less than 21 years of age”, issued at the address of the business.

**“Sale <21”** – The number of arrests for the charge of “sale of alcohol to a person less than 21 years of age”, issued at the address of the business.

It is important to note that the numbers given are only as accurate as the information put into the system. Using different search parameters will give very different results. The error factor should be very small and should not affect the overall goal of identifying potential problem locations.

**Subject:** Night Inspections

Night Inspections were conducted on 1/26/08. We were able to inspect twenty two buildings containing thirty two club occupancies in a four hour period. The inspection teams consisted of Team A: Inspector Kelly Derasmo, Fire Investigative Services Officer Sandy Ellison, Public Education Specialist Krista Gonzales and Sr. Staff Assistant Adrienne Baker; Team B: Inspector Steve Hesson, Deputy Fire Chief Hayes and Intern Deven Walther. Assistant City Manager Paul Folkers accompanied Team B from mid-night to two AM and stayed for the Hot Wash. Some of the common violations found during the inspections consisted of:
