ORDINANCE NO. 080193 1 2 0-07-115 3 4 An Ordinance of the City of Gainesville, Florida, annexing a portion 5 of the City of Gainesville Reserve Area pursuant to Chapter 90-496, 6 Special Act, Laws of Florida, as amended by Chapter 91-382 and 7 Chapter 93-347, Special Acts, Laws of Florida, known as the 8 Alachua County Boundary Adjustment Act: making certain 9 findings; including within the corporate limits of the City of 10 Gainesville, Florida, that certain compact and contiguous area 11 comprised of a portion of Tax Parcel 07240-000-000, as more 12 specifically described in this Ordinance, generally located south of the vicinity of Archer Road and Interstate 75, west of Interstate 75 13 14 and the City limits, north of Williston Road and SW 62nd Avenue 15 and east of SW 63rd Boulevard; providing for inclusion of the area 16 in Appendix I of the City Charter; providing for land use and zoning 17 regulations; providing directions to the City Manager and Clerk of 18 the Commission; providing a severability clause; and providing an 19 immediate effective date. 20 21 WHEREAS, Chapter 90-496, Special Act, Laws of Florida, as amended by Chapter 91-382 22 and Chapter 93-347, Special Acts, Laws of Florida, created the "Alachua County Boundary 23 Adjustment Act" (hereinafter collectively referred to as "the Act") which sets forth procedures for the 24 annexation of contiguous, compact, unincorporated territory within a municipality's reserve area; and 25 WHEREAS, on January 10, 2006, the Board of County Commissioners of Alachua County 26 designated the Reserve Area for the City of Gainesville pursuant to the Act; and 27 WHEREAS, on September 10, 2007, the City Commission voted to accept the Petition for 28 Voluntary Annexation submitted by the owner of the real property described herein and determined 29 that the Petition bore the signature of the owner of the property; and 30 WHEREAS, on November 26, 2007, the City Commission of the City of Gainesville adopted 31 Ordinance No. 070414, which adopted the Urban Services Report setting forth the plans to provide

1	urban services to that portion of the Reserve Area proposed to be annexed in accordance with the
2	procedures provided in the Act; and
3	WHEREAS, a copy of the Urban Services Report was filed with the Alachua County Board
4	of County Commissioners and was provided to the owners of the real property affected by this
5	ordinance; and
6	WHEREAS, the City Commission previously annexed a portion of the annexation area on
7	February 11, 2008 by Ordinance No. 070721; and
8	WHEREAS, the City of Gainesville desires to annex the remaining portions of a certain
9	portion of its Reserve Area which is compact and contiguous to the present corporate limits of the
10	City; and
11	WHEREAS, pursuant to law, notice of adoption of this ordinance was published for two
12	consecutive weeks prior to first reading in a newspaper of general circulation notifying the public of the
13	Public Hearing of this proposed Ordinance to be held in the City Commission meeting room, First
14	Floor, City Hall, in the City of Gainesville; and
15	WHEREAS, Public Hearings were held pursuant to the published notice described above at
16	which the parties in interest and all others had an opportunity to be and were, in fact, heard.
17	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
18	CITY OF GAINESVILLE, FLORIDA:
19	Section 1. The City Commission finds that the Area described in Section 2 of this Ordinance
20	(hereinafter referred to as the "Area") is reasonably compact and contiguous to the present corporate
21	limits of the City of Gainesville, and that no part of the Area is within the boundary of another

1 municipality or county. The City Commission finds the Area to be within its Reserve Area and the 2 annexation does not create an enclave. 3 Section 2. The following described Area is annexed and incorporated within the corporate 4 limits of the City of Gainesville, Florida: 5 See Legal Description attached hereto as Exhibit "A", and made a part 6 hereof as if set forth in full. 7 8 **Section 3.** The corporate limits of the City of Gainesville, Florida, as set forth in Appendix I, 9 Charter Laws of the City of Gainesville, are amended and revised to include the Area described in 10 Section 2 within the corporate limits of the City of Gainesville, Florida. 11 Section 4. The City Manager is authorized and directed to make the necessary change in the 12 Code of Ordinances of the City of Gainesville, Florida, to comply with this ordinance. 13 Section 5. In accordance with Section 171.062, Florida Statutes, the Alachua County land use 14 plan and zoning or subdivision regulations shall remain in full force and effect in the Area described in 15 Section 2 of this Ordinance until the City adopts a comprehensive plan amendment that includes the 16 annexed area. The Gainesville Code Enforcement Board and code enforcement officers shall have 17 jurisdiction to enforce these regulations during the interim period through the Gainesville Code 18 Enforcement Board process as described in Division 8 of Article V of Chapter 2 of the Code of 19 Ordinances of the City of Gainesville and the Civil Citation Process, as described in Division 6 of 20 Article V of Chapter 2 of said Code. During the interim period, the City may rezone properties in the

annexed area to an Alachua County Zoning classification/category that conforms with the Alachua

County Comprehensive Plan.

1	Section 6. If any word, phrase, clause, paragraph, section or provision of this ordinance or the
2	application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall
3	not affect the other provisions or applications of the ordinance which can be given effect without the
4	valid or unconstitutional provisions or application, and to this end the provisions of this ordinance are
5	declared severable.
6	Section 7. The Clerk of the Commission is directed to submit a certified copy of this
7	Ordinance to: 1) the Executive Office of the Governor; 2) the Florida Department of State; and 3) the
8	Clerk of the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida.
9	Section 8. This Ordinance shall become effective immediately upon adoption.
