WHEREAS, PNC Bank, successor to RBC Bank, which was successor to Millennium Bank transferred the Collateral Assignment to ASSIGNEE pursuant to Assignment dated October 27, 2014 and recorded in OR Book 4312, Page 1165 of the Public Records of Alachua County, Florida.

WHEREAS, ASSIGNOR has sold all the remaining units in The Palms Condominiums to ASSIGNEE pursuant to the Warranty Deed dated as of November 1, 2014 as recorded in OR Book _____, Page _____ of the Public Records of Alachua County, Florida in partial consideration of ASSIGNEE accepting a discounted payoff of the loan.

WHEREAS, ASSIGNOR is transferring and assigning all its rights, title and interest in, and its obligations under the Downtown Expansion Redevelopment Area Transformational Project Development Agreement to ASSIGNEE as partial consideration of ASSIGNEE accepting a discounted payoff of the loan.

WHEREAS, as successor to PNC and ASSIGNOR, ASSIGNEE has agreed to accept the Assignment of the Downtown Expansion Redevelopment Area Transformational Project Development Agreement and assume in writing, the responsibilities, obligations and duties associated with the interests being assigned by ASSIGNOR and PNC.

NOW THEREFORE, in consideration of the above and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties agree as follows:

 ASSIGNOR hereby grants, bargains, sells, assigns, transfers and sets over to ASSIGNEE all ASSIGNOR's rights, title and interest in, and its obligations under the Downtown Expansion Redevelopment Area Transformational Project Development Agreement.



- 2. ASSIGNEE hereby assumes the responsibilities, obligations and duties associated with the interests being assigned by ASSIGNOR and PNC.
- 3. ASSIGNOR authorizes and directs the Gainesville Community Redevelopment Agency ("CRA") to make all pending and future payments of Tax Increment Recapture Payments to ASSIGNEE, including specifically that payment due March 1, 2014 that had been held by the CRA.
- 4. ASSIGNOR hereby confirms that the Project is in compliance with all the Performance Benchmarks contained in Section 6 of the Downtown Expansion Redevelopment Area Transformational Project Development Agreement.
