26	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMISSION OF
27	THE CITY OF GAINESVILLE, FLORIDA:

29	Section 1. Designation of Elective Officials. That the City of Gainesville,
30	Florida herein designates all its elected positions for inclusion in the Elected Officers'
31	Class of the Florida Retirement System.

Section 2. That said designation	shall affect those elective officials in office after
the effective date of this designation.
