WHEREAS, the State of Florida Department of Transportation proposes to construct or improve State Road No. 26-A, Section No. 26070-2570, F.P. No. 2077901, in Alachua County, Florida; and

WHEREAS, it is necessary that certain lands now owned by **THE CITY OF GAINESVILLE, FLORIDA**, be used temporarily by the State of Florida Department of Transportation; and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation a temporary easement, or easements, in favor of the State of Florida Department of Transportation, for the purpose of tying in and harmonizing said property and the driveways, walkways, etc., thereon with the construction to be undertaken by the Department, in State Road 26-A adjacent thereto, and said request having been duly considered.


NOW THEREFORE, BE IT RESOLVED by the Board of City Commissioners of **THE CITY OF GAINESVILLE, FLORIDA**, that the application of the State of Florida Department of Transportation for a temporary easement, or easements, is for transportation purposes which is in the public or community interest and for public welfare; that a temporary easement, or easements, in favor of the State of Florida Department of Transportation in **THE CITY OF GAINESVILLE, FLORIDA**, should be drawn and executed by this Board of City Commissioners. Consideration shall be \$ 1.00.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded forthwith to the State of Florida Department of Transportation at Lake City, Florida.
