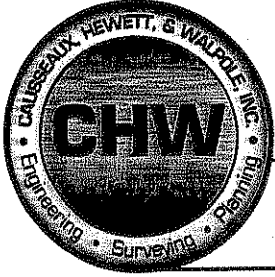

RE: Neighborhood Meeting Public Notice

Causseaux, Hewett, & Walpole, Inc. will be conducting a Neighborhood Workshop to discuss a proposed Large-scale Comprehensive Plan Amendment and Rezoning application on a ±31.3 acre site, located at approximately 4816 S.W. Archer Road. The two proposed actions will change the Future Land Use and Zoning categories from Alachua County categories to City of Gainesville categories, following the property's annexation into the City of Gainesville.

The Alachua County Land Use and Zoning Categories will be replaced with the City of Gainesville's categories of Planned Use District (PUD) and Planned Development (PD), respectively. The proposed land use and rezoning will permit an assisted living facility, a nursing home, dialysis / physical therapy centers, associated offices, and a residential component.

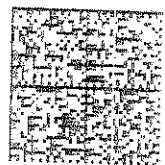

organization last year to help at-risk youth.

"It was a dream to try to make a difference in the community," Johnson said. "It's to help limit the crime going on in our community. The life lessons I learned from football helped make me who I am today."

Mike Thornton, one of the assistant coaches for the Gladiators, is a certified tutor who works with the students. "Any kid that has a D or lower has to come to tutoring," Thornton said. "They're not going to play in the game if they have any F's on their report card. To get back in, they come in an hour before practice."

In tutoring, Thornton helps students do their homework and teaches them basic classroom discipline.

"These kids want to play. If they aren't doing their work, they aren't going to play, and that hits them more than running laps or doing push-ups," he said. Practice throughout the week and all-day games on Saturdays keep the players busy and out of trouble, Thornton said.

The Gladiators hope to expand the program to include basketball, track and girls softball so students can be active all year.

"I think any time you can help any young kid or any youth is a good program," Thornton said. "These kids need role models. They need somebody that will take an interest in them, and that's something that I think is very valuable that we do," he said.

The Gainesville Gladiators try to get donations to pay for equipment and uniforms by hosting car washes and reaching out to local businesses, but Thornton said the children often must share their gear because of a lack of funding.

"We have to have help from the community a little bit. We're doing it pretty much on our own,"

he said. Saylor Transportation of Orlando is renting the team buses for half-price so they can go on the road early next month, said Thornton, who hopes to get more local sponsorship.

Out of the five teams last year, four went to the playoffs.

The 11- to 12-year-old team won the league championship.

This week, the Gladiators will play the Gainesville Gators Youth Football League, another nonprofit organization that was founded by

football player Willie Jackson, at the Eastside Recreation Center at 2041 E. University Ave.

Thornton said they're expecting more than 500 people to attend.

The five teams will play starting at 9 a.m. until 5 p.m.

City commissioners voted to hold the referendum through a mail ballot rather than opening up the precincts that are in the annexation area.

"We want people to participate. We don't want 50 people in an area with 1,000 to decide," Billings said. "By having everyone get a ballot, it will increase turnout."

Alachua County Supervisor of Elections Pam Carpenter said that either precincts on election day and a mail-in ballot would cost roughly the same for this specific election.

Carpenter said the mail ballot will cost somewhere between \$4,000 and \$4,100 while the traditional election was estimated between \$3,800 and \$4,000.

Resident Charles Kelly said he is concerned the mail ballot may not get the same response as an election day because residents might forget about the envelopes in the 20 days before they are due.

"People normally don't participate as much as they would in a statewide or national election," Kelly said. "But people had talked to had forgotten about the letter that was sent out to us. They were also not thinking about returning any ballot that was mailed out."

Kelly said he is opposed to joining the city because he enjoys the "quiet lifestyle" his home a mile from Newman's Lake affords.

The last day to register to vote for the election is Oct. 12 and Carpenter emphasized that people living in the area should make certain the addresses on their voter registration are up to date so they will receive a ballot.

City Commissioner Scherwin Henry said he supports the annexation push.

"It's not that a whole lot will change overall, but we will be able to bring about different services and recreation," Henry said. "There are individuals or households in the county that are still on septic but we will be able to bring about better recreation facilities."

Sponsors of SB 216 say it will prevent taxpayers money from going to

that is often political in nature, for example, an amendment about gay marriage or a controversial annexation.

Gainesville spent almost \$7,000 advocating for the annexation of the area along Southwest 20th Avenue.

The city is holding two informational meetings for residents to allow questions about the pros and cons of becoming a part of the city.

"The first question that's really asked is, 'Why I should and shouldn't be annexed into the city,'" Blackburn said. "That's a logical question that should be able to answer. It's a bad bill. It really restricts our ability to give information to people."

Residents can expect to pay higher property taxes in the city of Gainesville as compared to unincorporated Alachua County.

A property with a taxable value of \$40,000 after all exemptions will pay \$47.13 more a year in taxes as part of the city.

However, residents also generally have higher utility bills in the county due to a 25 percent surtax on water and a 10 percent surtax on gas and electric.

City of Gainesville residents can vote for both city and county commissioners.

Some Alachua County residents are hesitant to join the city because they enjoy a rural lifestyle that includes livestock, bonfires and firing guns.

There is a "rural city" land use that allows residents in Gainesville to have animals such as chickens and cows.

"People have to make the decision: Would it benefit me to be a part of the city?" Blackburn said. Blackburn said no one is certain if the bill extends as far as even preventing city employees from expressing an opinion about the matter. After all, they are paid with tax dollars, and he's not going to let his staff risk breaking the law.

In fact, when asked, "Why don't you tell me a little bit about this annexation?" Blackburn responded, "Because I don't want to go to jail."
