**RESOLUTION NO. 190367**

**A Resolution of the City Commission of the City of Gainesville, Florida, relating to the tentative budget for the City of Gainesville d/b/a Gainesville Regional Utilities for the fiscal year beginning October 1, 2019, and ending September 30, 2020; projecting revenues and adopting a tentative budget to pay for personnel services expenses, operating and maintenance expenses and other expenses, for capital outlay, and for debt service requirements; and providing an immediate effective date.**

**WHEREAS**, the City Commission held public hearings on the budget for the City of Gainesville d/b/a Gainesville Regional Utilities for the fiscal year beginning October 1, 2019, and ending September 30, 2020.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA;**

The Tentative Gainesville Regional Utilities Budget for the Fiscal Year Beginning October 1, 2019, and ending September 30, 2020 is adopted as follows:

**Section 1.** From the projected revenues shown on the schedule attached and made a part hereof as "Exhibit 1", titled "Gainesville Regional Utilities, Combined Systems," "Fiscal Year 2020 Budget" in the total amount of \$412,005,728, there are tentatively appropriated expenses for the purposes shown on the schedule in the total amount of \$412,005,728.

**Section 2.** From the projected revenues shown on the schedule attached and made a part hereof as "Exhibit 2", titled "Gainesville Regional Utilities, Electric System," "Fiscal Year 2020 Budget" in the total amount of \$285,134,353, there are tentatively appropriated expenses for the purposes shown on the schedule in the total amount of \$285,134,353.

**Section 3.** From the projected revenues shown on the schedule attached and made a part hereof as "Exhibit 3", titled "Gainesville Regional Utilities, Water System", "Fiscal Year 2020 Budget"

1 in the total amount of \$38,073,133, there are tentatively appropriated expenses for the purposes  
2 shown on the schedule in the total amount of \$38,073,133.

3 **Section 4.** From the projected revenues shown on the schedule attached and made a part  
4 hereof as "Exhibit 4", titled "Gainesville Regional Utilities, Wastewater System," "Fiscal Year 2020  
5 Budget" in the total amount of \$46,753,268, there are tentatively appropriated expenses for the  
6 purposes shown on the schedule in the total amount of \$46,753,268.

7 **Section 5.** From the projected revenues shown on the schedule attached and made a part  
8 hereof as "Exhibit 5", titled "Gainesville Regional Utilities, Gas System", "Fiscal Year 2020 Budget" in  
9 the total amount of \$27,613,535, there are tentatively appropriated expenses for the purposes  
10 shown on the schedule in the total amount of \$27,613,535.

11 **Section 6.** From the projected revenues shown on the schedule attached and made a part  
12 hereof as "Exhibit 6", titled "Gainesville Regional Utilities, GRUCom System," "Fiscal Year 2020  
13 Budget" in the total amount of \$14,431,439, there are tentatively appropriated expenses for the  
14 purposes shown on the schedule in the total amount of \$14,431,439.

15 **Section 7.** From the projected revenues shown on the schedule attached and made a part  
16 hereof as "Exhibit 7", titled "Gainesville Regional Utilities, Utility Plant Improvement Fund," "Fiscal  
17 Year 2020 Budget" in the total amount of available funds of \$64,204,181 there are tentatively  
18 appropriated Expenditures for the purposes shown on the schedule in the total amount of  
19 \$35,000,000.

20 **Section 8.** From the projected revenues shown on the schedule attached and made a part  
21 hereof as "Exhibit 8", titled "Gainesville Regional Utilities, Utilities System Debt Service Fund," "Fiscal

1 Year 2020 Budget” in the total amount of \$99,113,821, there are tentatively appropriated expenses  
2 in the total amount of \$99,113,821 for redemption of principal and interest.

3 **Section 9.** From the projected available resources shown on the schedule attached hereto and  
4 made a part hereof as "Exhibit 9", titled "Gainesville Regional Utilities, Construction Fund," "Fiscal  
5 Year 2020 Budget”, in the total amount available of \$149,749,994, there are tentatively  
6 appropriated Expenditures of \$98,500,962 for the purposes shown on the schedule.

7 **Section 10.** This Resolution shall become effective immediately upon adoption.
