**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, AUTHORIZING THE GRANT OF A PERPETUAL EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE.**

ON MOTION of Commissioner \_\_\_\_\_, seconded by Commissioner \_\_\_\_\_, the following Resolution was adopted;

WHEREAS, the State of Florida Department of Transportation proposes to improvements to the mast arm and signal light at the intersection of Southwest 16<sup>th</sup> Street and Southwest 16<sup>th</sup> Avenue, State Road No. 226, Section no. 26004, F. P. No. 4307501, in Alachua County, Florida; and

WHEREAS, it is necessary that portions of certain public right of way, Southwest 16<sup>th</sup> Street, maintained by the **CITY OF GAINESVILLE, FLORIDA**, be acquired by the State of Florida Department of Transportation for the signal light; and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation a perpetual easement in favor of the State of Florida Department of Transportation, for the purpose of replacing the mast arm and signal light at the intersection of Southwest 16<sup>th</sup> Street and Southwest 16<sup>th</sup> Avenue thereon with the construction to be undertaken by the Florida Department of Transportation and said request having been duly considered.

NOW THEREFORE, BE IT RESOLVED by the City Commissioners of the **CITY OF GAINESVILLE, FLORIDA**, that the application of the State of Florida Department of Transportation for a Perpetual Easement, is for transportation purposes which is in the public or community interest and for public welfare; that a Perpetual Easement, in favor of the State of Florida Department of Transportation in the **CITY OF GAINESVILLE, FLORIDA**, should be drawn and executed by this City Commissioners.
