BACKGROUND:

The Library's Board of Trustees consists of seven (7) members appointed by the Library Governing Board. Three (3) of the seven members are City of Gainesville representatives, three (3) are Alachua County representatives, and one (1) is a representative of the League of Cities. City Representative Grace "Betty" Taylor's term will expire on March 31, 1999. Ms. Taylor is eligible to serve an additional three year term on the Board of Trustees.

In accordance with the Alachua County Library District legislation, the Library Governing Board requests three (3) nominations (for the one vacancy), from the Gainesville City Commission to fill the one (1) City vacancy on the Library Board of Trustees.
