Gainesville's Future Energy Needs (B)

INTRODUCTION: Gainesville Regional Utilities (GRU) General Manager for Utilities gave introductions.

PRESENTATION: GRU Assistant General Manager for Strategic Planning Ed Regan gave a presentation.

MOTION: Commissioner Donovan moved and Commissioner Lowe seconded to:

- 1) Approve this as the scope of services as (as provided by GRU) and as to form and legality by the City Attorney;*
- 2) include Commissioner Lowe's suggested addendum to Appendix B with corrections in paragraph 2 removing the word "accurately" after GRU and paragraph 4 (b) change the word that to "than" (scrivener's error);*
- 3) include some of Commissioner Donovan's changes that Mr. Manasco read into the record that are on Page 1 under "Statement of Expectations for the Consultation" items 3 & 4 - change the first line in item 3 to read "The report shall provide fact finding and analysis that will help the City Commission identify the best alternative approaches for achieving these goals"; & item 4 - add the word "fact finding" before analysis in line 1;*
- 4) page 3 under "Selection of Consultants" change the language to read - "The City Commission Shall select one or more consultants";*
- 5) page 5 under "Access to Staff Resources" add the paragraph - "The consultant will also consider any written input from the public which is served by GRU" (deleting the word "solicit" from Commissioner Donovan's language);*
- 6) page 4 and 5 - delete Sunshine Law Compliance language;*
- 7) add language in that there would be (consultant) attendance at a City Commission meeting;*
- 8) Appendix B Concerns and Questions - Switch #1 with #7 making Customer Affordability #1.*
