Gainesville Police Department is in the process of renewing an agreement with the Department of Juvenile Justice to defray the security costs for the operation of the Gainesville Regional Juvenile Assessment Center for the period of October 1, 2012 - September 30, 2012. The department needs the requested funds from the City of Gainesville (which has been budged in the FY13 budget) to assist in funding for the cost of security. Without the funding DJJ would be unable to have a 24 hour coverage which would mean GPD would be responsible for a juvenile until a legal guardian was contacted and the juvenile picked up. Alachua County Sheriff's Office also gives money to DJJ for theses services. It can not be bid out since this is the State of Florida Department of Juvenile Justice Center. This is the only place for these services.
