A resolution authorizing the City Manager to execute a joint participation agreement between the City of Gainesville and the Florida Department of Transportation (FDOT) to receive Service Development Funds for the Campus Circulation Route/s:

WHEREAS, the City of Gainesville owns and operates the public transit system serving the Gainesville urbanized area in Alachua County;


WHEREAS, the Florida Department of Transportation (FDOT) makes available service development grant funds for transit operating assistance each year;

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provision by the local share of the project costs; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:


1. That the City Manager or his designee is authorized to execute joint participation agreement (FP # 215541-1-9401) for FDOT service development funds for refurbishing Oaks Mall Park and Ride Lot on behalf of the City of Gainesville, Florida with the Florida Department of Transportation.
2. That the City of Gainesville Regional Transit System (RTS) and the Oaks Mall will provide the local share to match, such service development grant funds as may be authorized within the City of Gainesville's approved budget.
3. This resolution shall become effective immediately upon adoption.

GAINESVILLE' "


WHEREAS, the City of Gainesville, Florida has made the following determinations:

1. The City of Gainesville, Florida adopted on November 13, 1991 the Comprehensive Plan by Ordinance 3749; and
2. The adopted comprehensive plan, through the Conservation and Recreation Element supports the concepts of City Wide Greenways and Recreational Trail Systems.

NOW, THEREFORE BE IT RESOLVED by the City of Gainesville, Florida, as follows;

1. The City of Gainesville will continue to pursue regulatory measures and land acquisition programs, which implement these ecological greenways and recreational trail networks.
