13	public hearing was given that the Future Land Use Map be amended by changing the land use		
14	category of certain properties from "Industrial" to "Commercial"; and		
15	WHEREAS, notice was given and publication made as required by law and a public		
16	hearing was held by the City Plan Board on October 20, 2005; and		
17	WHEREAS, the amendment to the land use category of the City of Gainesville 2000-2010		
18	Comprehensive Plan proposed herein directly relates to a small scale development activity as		
19	provided in Chapter 163, Florida Statutes; the City of Gainesville will transmit copies of the public		
20	notice and this proposed change to the State Land Planning Agency, the regional planning council,		
21	and any other person or entity who has requested a copy for their comments subsequent to the		
22	passage of this ordinance; and		
23	WHEREAS, at least ten (10) days notice has been given of a public hearing once by		
24	publication in a newspaper of general circulation notifying the public of this proposed ordinance		
25	and of a Public Hearing in the City Commission meeting room, First Floor, City Hall in the City of		
26	Gainesville; and		

1	WHEREAS, pursuant to law, notice has also been given by mail to the owner whose		
2	property will be regulated by the adoption of this Ordinance, at least ten days prior to the date set		
3	for a public hearing on this ordinance; and		
4	WHEREAS, the public hearing was held pursuant to the published notice described above		
5	at which hearing the parties in interest and all others had an opportunity to be and were, in fact,		
6	heard.		
7	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE		
8	CITY OF GAINESVILLE, FLORIDA:		
9	Section 1. The Future Land Use Maps of the City of Gainesville 2000-2010		
10	Comprehensive Plan are amended by changing the land use category of the following described		
11	property from "Industrial" to "Commercial":		
12	See legal description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.		
14 15	Section 2. The City Manager is authorized and directed to make the necessary changes in		
16	maps and other data in the City of Gainesville 2000-2010 Comprehensive Plan, or element, or		
17	portion thereof in order to comply with this ordinance.		
18	Section 3. If any section, sentence, clause or phrase of this ordinance is held to be invalid		
19	or unconstitutional by any court of competent jurisdiction then said holding shall in no way affect		

the validity of the remaining portions of this ordinance.

Section 5. This ordinance shall become effective immediately upon passage; however, the amendment to the City of Gainesville 2000-2010 Comprehensive Plan shall become effective thirty one (31) days after passage and adoption of this Ordinance unless a petition is filed with the Division of Administrative Hearings pursuant to § 163.3187(3), F.S. In this event this Ordinance shall not become effective until the state land planning agency issues a final order determining the adopted amendment to be in compliance in accordance with § 163.3187, or until the Administration
