110779. Agricultural Uses in Residential Districts (B)

Planning Manager, Ralph Hilliard, gave an overview of this item and the report presented to the Committee for their consideration. Based on the report staff recommended that the animal control ordinance be amended to allow up to 4 chickens on lots of 10,000 square feet or less, and up to 6 chickens on lots greater than 10,000 square feet. Property zoned RSF-R is currently allowed to have 20 chickens per acres and that would continue.

After discussion among the Committee, staff, and citizens, Commissioner Wells made the following motion with a second from Commissioner Hinson-Rawls.

MOTION: Move this item to the City Commission with a request to direct staff to initiate a Petition to the Plan Board incorporating the following components:

- 1. Allow up to four chickens in residentially zoned areas of the City on lots that are 10,000 square feet or less;*
- 2. Allow up to six chickens in residentially zoned areas of the City on lots that are 10,001 square feet or greater;*
- 3. Disallow Roosters;*
- 4. Require some type of enclosure (coop or fencing) to manage the keeping of chickens;*
- 5. Ensure that existing ordinances pertaining to nuisance abatement are enforced; and,*
- 6. Remove the referral from the CDC pending referral list.*

RECOMMENDATION *The Community Development Committee hear a presentation of the information from staff and provide direction as deemed appropriate.*

100001. Transfer of Development Rights (B)

Staff reviewed this existing pending referral with the Community Development Committee. After reviewing information on Transfer of Development (TDR) programs generally (and components of the Alachua County TDR program specifically) and based upon current densities provided in the City's core and the perceived lack of an existing market for the TDR mechanism the Committee directed that staff have this item removed from the Committee's pending referral list.

MEMBER COMMENT

Commissioner Hinson-Rawls made staff aware of several concerns that citizens brought to her attention recently. Groups have approached him with these ideas and potential development in some vacant buildings in town such as the Alachua County Extension offices, the former Army Reserve property, the Power District buildings, or the old Spin Cycle building. The Committee discussed establishing criteria for the spaces and how this item can be discussed again in the future at the Committee level, at the Commission level, or with staff.
