

RESOLUTION NO. 140685

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, AUTHORIZING THE GRANT OF A PERPETUAL DRAINAGE EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE.**

ON MOTION of Commissioner                     Poe                    , seconded by Commissioner                     Carter                    , the following Resolution was adopted;

WHEREAS, the State of Florida Department of Transportation proposes to improvements to Archer Road State Road No. 24, in Alachua County, Florida; and

WHEREAS, the State of Florida Department of Transportation has stormwater drainage rights from Archer Road, State Road No 24, to stormwater retention ponds, located in the Butler Plaza complex; and

WHEREAS, it is necessary that portions of certain public right of way, Southwest 43<sup>rd</sup> Street, maintained by **THE CITY OF GAINESVILLE, FLORIDA**, be used by the State of Florida Department of Transportation for connection of two stormwater retention ponds; and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation a perpetual easement in favor of the State of Florida Department of Transportation, for the purpose of stormwater drainage connection, thereon with the construction to be undertaken by the Florida Department of Transportation to Archer Road, State Road 24, and said request having been duly considered.

NOW THEREFORE, BE IT RESOLVED by the City Commissioners of **THE CITY OF GAINESVILLE, FLORIDA**, that the application of the State of Florida Department of Transportation for a Perpetual Drainage Easement, is for transportation purposes which is in the public or community interest and for public welfare; that a Perpetual Drainage Easement, in favor of the State of Florida Department of Transportation in **THE CITY OF GAINESVILLE, FLORIDA**, should be drawn and executed by this City Commissioners. 


