A Resolution approving the final plat of "Sorrento, Phase II A Planned Development", generally located in the vicinity of N.W. 21st Drive and N.W. 53rd Avenue, south side; accepting an irrevocable letter of credit; providing directions to the Clerk of the Commission; and providing an immediate effective date.

WHEREAS, the Development Review Board approved the design plat of "Sorrento, Phase II A Planned Development" on October 9, 2003; and

WHEREAS, the owner of the plat has submitted a final plat which substantially conforms to the design plat as approved by the City Commission on November 10, 2003, and which incorporates all modifications and revisions specified in such approval; and

WHEREAS, the owner of the proposed subdivision has requested the City Commission to accept and approve the final plat as provided in Chapter 177 of the Florida Statutes and Chapter 30 of the Code of Ordinances of the City of Gainesville, Florida; and

WHEREAS, the City Commission finds that the final plat described herein is consistent with the City of Gainesville 2000-2010 Comprehensive Plan, and applicable ordinances and regulations of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA;

Section 1. The final plat of "Sorrento, Phase II A Planned Development" is accepted and approved by the City Commission on the following described property lying in the City of Gainesville, Alachua County, Florida:

Section 2. The City accepts the irrevocable letter of credit dated January 15, 2004 and Amendment No. 001 dated February 2, 2004, issued by SunTrust Bank, in the amount of \$578,000.00 to guarantee the completion of the subdivision improvements as provided by the Land Development Code. The original letter of credit shall remain on file with the Public Works Department until the City is satisfied that all construction of required subdivision improvements have been completed.

Section 3. The Clerk of the Commission is authorized and directed to affix his signature to the record plat on behalf of the City Commission and accept the dedication of public rights-of-way, easements, and other dedicated portions as shown on the plat.

Section 4. This resolution shall be effective immediately upon adoption.
