4	An ordinance of the City of Gainesville, Florida, amending the Zoning
5	Map Atlas and rezoning certain property within the City from "RH-2:
6	8-100 units/acre residential high density district" to "Urban Mixed-
7 8	Use District (UMU-2)"; consisting of approximately five acres, located in the vicinity of the University Heights neighborhood, generally
9	bounded on the north by Southwest 3rd Avenue, on the west by
10	Southwest 13th Street, on the east by SW 12th Terrace and on the south
11	by Southwest 5th Avenue; providing a severability clause; providing a
12	repealing clause; and providing an effective date.

15	WHEREAS, by initiation of a petition by the property owner, publication of notice of a
16	public hearing was given that the Zoning Map Atlas be amended by rezoning certain property
17	within the City from the zoning category of "RH-2: 8-100 units/acre residential high density
18	district" to "Urban Mixed-Use District (UMU-2)"; and
19	WHEREAS, notice was given and publication made as required by law and a public
20	hearing was held by the City Plan Board on July 20, 2006; and
21	WHEREAS, the City Commission finds that the rezoning of the property described
22	herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and
23	WHEREAS, at least ten (10) days notice has been given of the public hearings once by
24	publication in a newspaper of general circulation notifying the public of this proposed ordinance
25	and of a Public Hearing in the City Commission meeting room, First Floor, City Hall, in the City
26	of Gainesville; and
27	WHEREAS, pursuant to law, notice has also been given by mail to the owner whose
28	property will be regulated by the adoption of this Ordinance, at least thirty days prior to the

I.	adoption of this ordinance; and
2	WHEREAS, the public hearing was held pursuant to the published and mailed notice
3	described above at which hearing the parties in interest and all others had an opportunity to be
4	and were, in fact, heard.
5	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
6	CITY OF GAINESVILLE, FLORIDA:
7	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the
8	following described property from the zoning category of "RH-2: 8-100 units/acre residential
9	high density district" to "Urban Mixed-Use District (UMU-2)":
10 11	See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.
12 13	Section 2. The City Manager is authorized and directed to make the necessary changes in
14	the Zoning Map to comply with this Ordinance.
15	Section 3. If any section, sentence, clause or phrase of this ordinance is held to be invalid
16	or unconstitutional by any court of competent jurisdiction, then said holding shall in no way
17	affect the validity of the remaining portions of this ordinance.
18	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
19	such conflict hereby repealed
20	Section 5. This ordinance shall become effective immediately upon final adoption;
21	however, the rezoning shall not become effective until the amendment to the City of Gainesville

2000-2010 Comprehensive Plan adopted by Ordinance No. 060229 becomes effective as

provided therein
