Ordinance No. 0-05-71

An ordinance of the City of Gainesville, Florida, Chapter 9, Elections; amending Section 9-5 of the Code of Ordinances, providing that the proclamation calling the election shall be issued at least thirty days prior to the election; renumbering Section 9-11 to Section 9-10 of the Code of Ordinances, providing that this section only pertains to qualifications of candidates for city commission: creating a new Section 9-11 of the Code of Ordinances, providing for campaign contribution limitations and campaign finance reports; providing directions to the Codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

Recommendation: The City Commission adopt the proposed ordinance.

The City Commission, at its meeting of December 13, 2004, authorized the City Attorney's Office to draft and the Clerk of the Commission to advertise an ordinance amending Chapter 9, Elections, of the Code of Ordinances, regulating city commission campaign contributions the same as the limitations of Alachua County. Additionally, this Office has initiated an amendment to Section 9-5 of the Code clarifying that the mayor issues a proclamation calling the election at least 30 days prior to the election.

| 19 | WHEREAS, the City Commission finds that the financing of political campaigns for |
| 20 | City government elected officials is a matter of substantial concern to the residents of the City of |
| 21 | Gainesville; and |
| 22 | WHEREAS, expenditures for city elections have risen substantially in the past decade; |

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE

CITY OF GAINESVILLE, FLORIDA:

- Section 1. Section 9-5 of the Code of Ordinances of the City of Gainesville is amended
- 9 to read as follows:
- Sec. 9-5. Mayor to issue proclamation; contents; publication.
- At least Tthirty days prior to any and all elections for mayor or commissioners the mayor

shall issue a proclamation calling the election. The proclamation shall specify what officers are

- to be elected, the length of time the officers are to serve and the time and date of holding the
- election. Such proclamation shall be published once in a newspaper of general circulation
- published in the city.
- Section 2. Section 9-11 of the Code of Ordinances of the City of Gainesville is
- 17 renumbered to 9-10 and is amended to read as follows:
- Sec. 9-101. Qualifications of candidates for city commission; campaign finance
- 19 reports.
- 20 (a) Any person who meets the eligibility requirements described in Article II of the
- 21 Charter may become a candidate for the office of mayor or city commissioner of the city by filing
- 22 the necessary qualifying papers as provided in Florida Statutes with the supervisor, at any time
- after noon of the first day for qualifying which shall be the fiftieth day prior to the day of the

election, but not later than noon of the 46th day prior to the day of the election. Provided, however, as a condition precedent to having his/her name printed on the ballot for such election such person shall pay to the supervisor the election assessment imposed by Fla. Stat. §99.093(1), or be exempted from such payment of assessment pursuant to the provisions of Fla. Stat. §99.093(2). Any person who is seeking election as a write-in candidate shall not be required to pay a filing fee or submit a petition. A write-in candidate shall not be entitled to have his/her name printed on any ballot; however, space for his/her name to be written in shall be provided on the ballot. No person may qualify as a write-in candidate if the person has also otherwise qualified for nomination or election to such office. All write-in candidates must submit their qualifying paperwork to the supervisor by the end of the qualifying period set out above.

(b) Reports of all contributions received, and all expenditures made by:

(1) A candidate; or

(2) A political committee, as that term is defined in Fla. Stat. Ch. 106, that has made contributions or expenditures to influence the results of a city election, shall be filed on the 32nd, 18th and fourth days immediately preceding the regular or special election, and, if a run-off is required, on the fourth day immediately preceding the run-off election.

For purposes of determining the eligibility requirements of Article II of the Charter, a person who resides in an area that is redistricted into another district (hereinafter the "new district") shall be deemed to be a resident of the new district if the person resides anywhere within the area that is placed in the new district for a period of not less than six months prior to the date the person qualifies to run for office.

| 22 | affect the validity of the remaining portions of this ordinance. |
