#### DISCUSSION OF PENDING REFERRALS

130769. Synthetic Drug Ordinance Proposal (B)

This item requests the Public Safety Committee consider the creation of a City ordinance to prohibit the possession, sale, display for sale, or manufacture of synthetic drugs in Gainesville; to assist in combatting the rise in the sale and use of dangerous synthetic substances commonly known as "spice".

#### RECOMMENDATION

The Public Safety Committee 1) hear a presentation from GPD staff; and 2) consider whether an ordinance prohibiting the sale, distribution, production, manufacture, or display for sale or marketing of synthetic drugs within the city limits of Gainesville would benefit law enforcement in combatting the increased use and availability of these drugs.

Attorney Shannon MacGillis from the HIDTA (High Intensity Drug Trafficking Area) Office in Jacksonville explained to the Public Safety Committee types of synthetic drugs (bath salts, spice, and mollies). The contents of the package is uncertain and continually changing so the HIDTA encourages Florida cities to regulate the packaging as a first step to regulate the sale of these drugs through State Statute 499.033. The new regulations would be geared for the sellers, not the users.

HIDTA is making adjustments to a proposed ordinance and will send it to the City when complete. At that time Assistant City Attorney Lee Libby will review the proposed ordinance and present his findings to the Public Safety Committee and at the request of the Committee, include a phrase regarding possession and use of the drugs.
