seconded to direct staff to provide information regarding: 1) Grounds for denying or for not denying a permit for Koppers and what the process would be to close Koppers; 2) the value of undertaking further tests of dust, blood and hair; 3) EPA's explanation for restoration of the property to "commercial standard" and why not "residential standard"; 4) what Gainesville would need to do to restore the property to the "residential standard" if the EPA was not willing to do that; 5) reconciliation of the EPA and GRU reports regarding the proper level of hydrologic containment or withdrawal; 6) stormwater treatment in the area to the Public Works staff; and 7) that the City share this information with the County.

GRU/City Attorney Skip Manasco and Department of Environmental Protection Representative Kelsey Helton made comments.
