090168. Efficacy and Safety of Fluoridating Our Public Water Supply (B)

The Regional Utilities Committee (RUC) heard a presentation by Tony Cunningham, Supervising Water/Wastewater Engineer regarding GRU's fluoridation program.

Mrs. Karen Eberly gave a presentation regarding her concerns with the fluoridation of GRU's water supply.

Commissioner Lowe asked if there was a difference between the topical effect versus the ingestion of fluoride. Kip Ducheon from the Center for Disease Control responded via phone that it was beneficial both ways. Commissioner Lowe asked if there was a disproportionate level of crippling skeletal fluorsis in Gainesville compared to communities that do not have fluoridated water. Kip Ducheon responded that there were only six cases in the United States and none in Gainesville.

Mayor Hanrahan asked representatives from the local dentist association what the experience is in Gainesville. Did they see a point at which there is too much fluoride? Dr. Burt Hughes responded that the dental community did not see fluorsis at any significant level in Gainesville.
