WITNESSETH that for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, receipt and sufficiency of which is hereby acknowledged, the grantor hereby gives, grants, bargains and releases to the grantee, a temporary construction easement for the purpose of constructing a pipe connection to the City's sediment box, and tying in and harmonizing said property and the driveways, walkways, etc., thereon with the construction to be undertaken by the Department, in State Road No. 329 (Main Street) adjacent thereto, in, upon, over and through the following described land in Alachua County, Florida, viz:

THIS EASEMENT shall be for a period of 12 months commencing on the date the grantor executes this easement.

Upon completion of construction Grantee agrees to restore the surface of the property as near as possible to the same condition that existed prior to construction.

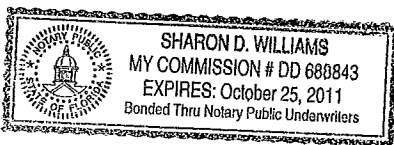
