A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA; RELATING TO ITS GENERAL GOVERNMENT BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015 AND ENDING SEPTEMBER 30, 2016; AMENDING RESOLUTION NO. 150271, AS AMENDED BY RESOLUTION NO. 150744, RESOLUTION NO. 160024 AND RESOLUTION NO. 160258, BY MAKING CERTAIN ADJUSTMENTS TO THE GENERAL GOVERNMENT FINANCIAL AND OPERATING PLAN BUDGET; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE.

WHEREAS, on September 17, 2015, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 150271 for the purpose of approving and adopting a final budget for Fiscal Year 2015-2016;

WHEREAS, the City Commission adopted Resolution No. 150744, Resolution No. 160024 and Resolution No. 160258 which amended Resolution No. 150271 by amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, it is necessary to make certain amendments to the General Government Financial and Operating Plan Budget in order to fund its activities;

WHEREAS, the City Commission desires now to amend the General Government Financial and Operating Plan Budget as fully set forth below.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

1 **Section 1.** The General Government Financial and Operating Plan Budget for Fiscal
2 Year 2015-2016 is hereby amended as set forth in Attachment “A” which is attached hereto and
3 made part hereof as if set forth in full.

4 **Section 2.** Except as herein above modified and amended, the General Government
5 Financial and Operating Plan Budget for Fiscal Year 2015-2016 as adopted by Resolution No.
6 150271 and amended by Resolution No. 150744, Resolution No. 160024 and Resolution No.
7 160258 shall continue and remain in full effect.

8 **Section 3.** This Resolution shall become effective immediately upon adoption.
