An ordinance of the City of Gainesville, Florida, amending Appendix A of the Code of Ordinances to add a surcharge for Fast Track building permits; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.

Recommendation:

The City Commission adopt the proposed

ordinance.

The City Commission at its meeting of July 26, 1999, authorized the City Attorney to draft and the Clerk of the Commission to advertise an ordinance for Fast Track Permitting, a new pilot program within the Building Department which would allow contractors, developers, and owners to request Fast Track service when making an application for permit. Appendix A would need to be amended to add the Fast Track surcharge fee, which would be equal to the permit fee amount, not to exceed \$350.00.

14	described at which hearing the parties in interest and all others had an opportunity to be
15	and were, in fact, heard;
16	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF
17	THE CITY OF GAINESVILLE, FLORIDA:
18	Section 1. Section (10) of the BUILDINGS AND BUILDING REGULATIONS charges
19	in Appendix A of the Code of Ordinances is amended to read as follows:
20	APPENDIX A - SCHEDULE OF FEES, RATES AND CHARGES
21	BUILDINGS AND BUILDING REGULATIONS:
22	(10) Special services:
23	a. Pre-plan review, one-half building permit fee. Valuation is
24	based on cost per square foot and type of construction. This fee
25	will be applied to the building permit application.
26	b. After-hours inspection 65.00
77	C Fast Track surcharge; equal to permit fee not to exceed 250.00

1	Section 2 . It is the intention of the City Commission that the provisions of Section 1 of		
2	this Ordinance shall become and be made a part of the Code of Ordinances of the City of		
3	Gainesville, Florida, and that the Sections and Paragraphs of this Ordinance may be		
4	renumbered or relettered in order to accomplish such intentions.		
5	Section 4. If any section, sentence, clause or phrase of this ordinance is held to be invalid		
6	or unconstitutional by any court of competent jurisdiction, then said holding shall in no		
7	way affect the validity of the remaining portions of this ordinance.		
8	Section 5. All ordinances, or parts of ordinances, in conflict herewith are to the extent o		
9	such conflict hereby repealed.		
10	Section 6. This ordinance shall be effective immediately upon final adoption.
