However, this lawsuit is related to the prospectus that was given to the Buck Bay residents by the previous owner. A hearing has been scheduled for March 25, 2008 to try to resolve these issues. Any interested parties can call 800-351-4871 and enter participant code 11351740# at 9:30 am to listen to the FMHRC board discussions.</p> <p>The City's General Fund Mobile Home Relocation Program requires that the applicant be approved by the FMHRC before they can receive City funds. Since the FMHRC has withdrawn all prior application approvals and suspended the processing of any new applications for Buck Bay residents until the legal issues have been resolved; no Buck Bay resident who is relocating to a mobile home can access City funds until the FMHRC has resolved the legal issues and begin to process applications from Buck Bay residents.</p> <p>Since December 2007, fifteen (15) families have applied for relocation assistance to relocate within either the City limits and/or the incorporated areas of Alachua County. It is not determined at this time if these families will be relocating within the City limits (HOME funded) or the incorporated areas of Alachua County (General Fund). Since the inception of the HOME funded Displaced Mobile Home Owner/Tenant Assistance Program, two families have received relocation assistance with two families pending assistance.</p>
