 - **Section 15.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of such conflict hereby repealed.
 - **Section 16.** This ordinance shall become effective immediately upon final adoption; however, the rezoning shall not become effective until the amendment to the City of Gainesville


