Ordinance No. 0-05-60; Petition 54TCH-05 PB

An ordinance of the City of Gainesville, Florida, amending the Land Development Code, relating to the residences for destitute people and food distribution centers for the needy; amending subsection 30-110(d), increasing the number of beds in a residence for destitute people; amending subsection 30-111(1), increasing the total number of meals served to the needy in a 24-hour period; amending paragraph (1) of subsection 30-91(d), increasing the total number of beds in a residence for destitute people that is accessory to a place of religious assembly; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

Recommendation: The City Commission (1) approve Petition No. 54TCH-05 PB, and (2) adopt the proposed ordinance.

#### COMMUNITY DEVELOPMENT DEPARTMENT STAFF REPORT

The Community Development Committee of the City Commission held meetings in December 2004 and January 2005 to discuss issues relating to homelessness. The findings reported by the committee were that the community had grown and, therefore, the number of beds provided at residences for the destitute and the number of meals provided at food distribution centers should grow to meet the need. The goal of dispersed facilities still remains a goal. The City Commission discussed the Committee's recommendations, in January and February 2005, and initiated the petition to update these code sections.

The proposed amendment to Sec. 30-110(d) is to raise the total number of beds that may be provided in any residence for destitute people from 30 beds to 35 beds.

The proposed amendment to Sec. 30-111(1) is to raise the total number of meals served in any 24-hour period from 75 to 130. The meals served to the needy are in addition to the meals served for residents of a residence for destitute people, consistent with the current language in this section.

The proposed amendment to Sec. 30-91(d) is to raise the total number of beds that may be provided in a residence for destitute people that is accessory to a place of religious assembly

#### Recommendation

Planning Division staff recommends approval of Petition 54TCH-5PB.

### **Explanation**

The Community Development Committee of the City Commission held meetings in December 2004 and January 2005 to discuss issues relating to homelessness. The findings reported by the committee were that the community had grown and therefore the number of beds provided at residences for the destitute and the number of meals provided at food distribution centers should grow to meet the need. The goal of dispersed facilities still remains a goal. The City Commission discussed the Committee's recommendations, in January and February 2005, and initiated the petition to update these code sections.

The proposed amendment to Sec. 30-110(d) is to raise the total number of beds that may be provided in any residence for destitute people from 30 beds to 35 beds.

The proposed amendment to Sec. 30-111(1) is to raise the total number of meals served in any 24-hour period from 75 to 130. The meals served to the needy are in addition to the meals served for residents of a residence for destitute people, consistent with the current language in this section.

The proposed amendment to Sec. 30-91(d) is to raise the total number of beds that may be provided in a residence for destitute people that is accessory to a place of religious assembly from 15 to 20. Meals may be provided only to residents. The code provides that a special use

# Sec. 30-110. Residences for destitute people

(d) Number of beds. The total number of beds that may be provided in any residence for destitute people in a twenty-four hour period is thirty (30) thirty-five (35).

# Sec. 30-111. Food Distribution centers for the needy.

(1) Limit on number of meals served. The total number of meals served in any 24-hour period shall not exceed 75 130. Such number shall not include meals serve to persons admitted to a residence for destitute persons when located in conjunction with a food distribution center for the needy.

## Sec. 30-91. Places of religious assembly.

- (d) Residences for destitute people. The city manager or designee may issue a permit for a residence for destitute people within any zoning district where places of religious assembly are permitted by right or by special use permit with the following restrictions:
  - (1) The total number of beds that may be provided in a residence for destitute people that is accessory to a place of religious assembly is 15 20.

RE: Proposed increase in number of clients @ Homeless Shelters and Soup Kitchens

The problem of homelessness is not new, yet in my opinion federal help alone will not solve it. Intended to revive the inner cities, Lyndon Johnson's Great Society resulted in the relationship of social service communities to neighborhood as a dependency mode. The program reduced the level of urban and rural poverty, mostly through Medicaid and food stamps. Increased federal spending in these areas, however, coincided with rising unemployment, crime, and drug trafficking. Therefore, the gains of the program were offset by new problems, and urban America is still working to solve the issues of race and inequality.

Worsening the problem of homelessness were the changes to the mental health system in the 1980s, resulting in many mentally disabled individuals living on the streets. In my neighborhood recently a problem has occurred when a concerned neighbor offered temporary shelter to a single homeless woman in a van parked in the front yard. Other neighbors are sensitive of the problem of homelessness, but also are concerned about the impact on children seeing an adult living in this situation, the problem of fire hazard with someone living in a vehicle, and the fact that the homeless woman was showering outside with a garden hose. The neighborhood has asked that the situation end. I recount the story to make you aware that if shortage of shelter space exists, there are temporary attempts to provide shelter that could have an adverse impact on the community.

I also realize some persons are concerned that if Gainesville makes life on the streets too convenient, it may result in negative impacts to the community. I think we should provide decent housing to homeless individuals but require some progress by requiring they be involved in job training when appropriate or some work if available if they are not impaired by health problems. One of the most popular New Deal agencies, the Civilian Conservation Corps, had a special program for unemployed WWI veterans.

I understand from conversations with others more knowledgeable of the service system for homeless individuals that there is an economy of scale in service delivery. Therefore I support the proposed increase in the number of persons served at homeless shelters and soup kitchens in Gainesville. I do think there should be a requirement for control of any litter, and restrictions placed on bringing food outside for this reason.

I am unable to attend the meeting to present my opinion due to an event with the Lincoln Middle School Band. Thank you for considering my views.

Ms. Carolyn Morgan was recognized. Ms. Morgan explained that the petition came about through discussions of the Community Development Committee and the City Commission. She noted that meetings were held in December 2004 and January 2005 to discuss issues related to homelessness. She indicated that it had been determined that residences for destitute people and the number of meals provided at food distribution centers should be increased to meet the need. Ms. Morgan stated that the number of beds allowed at residences for destitute people would rise from 30 to 35, the number of meals served at food distribution centers would increase from 75 to 130, and would allow residences for destitute people and food distribution for the needy in places of religious assembly. She explained that the number of beds allowed in a residence for destitute people allowed by Special Use Permit as accessory to a place of religious assembly would rise from 15 to 20. Ms. Morgan offered to answer any questions from the board.

Mr. Reiskind asked if the increase reflected the demand for services.

Ms. Morgan explained that it was the finding of the Commission committees that the demand was greater than e number of beds and meals available.

Mr. Gold asked if there was opposition to the increase from downtown business associations.

Ms. Morgan stated that she did not know since she did not personally participate in the meetings.

Chair Cole opened the floor to public comment.

Mr. Kent Van, Director of St. Francis House, was recognized. Mr. Van stated that the increase was based on need for more beds and meals served.

Mr. Rwebyogo asked about the service of meals.

Mr. Van stated that St. Francis House currently served 75 people at lunch, but needed to increase it to 130.

Mr. Rwebyogo asked where people went after lunch.

Mr. Van explained that many had jobs as day laborers.

Mr. Reiskind asked if Mr. Van believed the increase in capacity would be sufficient.

1. Van indicated that, at the present time, it would be sufficient. He explained that there was a survey performed every year and there had been an increase in families requiring shelter.

These minutes are not a verbatim account of this meeting. Tape recordings from which the minutes were prepared are available from the Community Development Department of the City of Gainesville.

Ms. Miriam Elliott, Case Manager for St. Francis House, was recognized. Ms. Elliott discussed the operation of the shelter and the need for more beds. She noted that it was not just the homeless who ate lunch at the shelter. She explained feeding such people allowed them to spend their income on shelter, thereby keeping them from homelessness. She requested that the board support the petition.
