I would like to thank you for contacting me regarding the proposed fire assessment. I assure you that I do not approach this issue lightly and I will strongly consider all input before making my final decision. I will weigh several alternatives to keeping our fire department fully funded, including making drastic budget cuts, raising the millage rate on property owners, and assessing a fire fee for service (so long as it is minimal and includes a sunset clause). I take none of these options lightly, as they all will have serious consequences on all or part of our community.

As for the rate structure, the various rates were determined by utilizing an exhaustive scientific analysis of GFR responses over the course of one year. The study looked at all responses, and eliminated any that did not directly relate to fire services (i.e. no EMT or car accident responses were included). This was used determine the overall cost of providing fire services to the city (\$7,3342,466). The study then looked at various types of properties and what portion of fire services each property classification utilized. This is how we arrived at the \$99 per residential unit, \$.18/sq. foot for institutional, etc. It is all based on the proportional share of calls GFR answered and dedicated fire services to over the entire year. Churches fall under the institutional category; therefore they would be assessed at a rate of \$.05/sq. foot if the assessment is passed at a 25% rate. I am not sure if I did an adequate job of explaining the methodology of the rate structure, so if you want additional information, I suggest you contact Chief Northcutt (northcutwk@ci.gainesville.fl.us), who is much better at articulating the science behind the process.

Thank you for all that you do for our community. As a former chair of the CACCD, I have seen first-hand the direct impact you and your members make on our city.

Hello,

My name is Dr. Omjoy Ganesh. I am a homeowner and a resident of Gainesville for over 20 years. I wanted to let you know of my unhappiness over the proposed special assessment for fire services. I understand the benefit that fire services provide. My concern is with another fee being passed onto local residents. For some time now local residents have been rather quietly swallowing new fees and higher rates. The slow nickel-and-diming is taking its toll. From increased GRU rates (every year), to changes in property tax assessments (indeed, my property taxes nearly doubled from last year to this year), this proposed special assessment for fire services feels like throwing a log on an already burning fire.

Public services are necessary, and services in Gainesville are top notch. However, something is wrong. Homeowners and residents paying more in taxes then ever before, yet we are still hearing that social services, police, fire, and public schools are hurting. Broad statements like: "...at the end of the day, ultimately, it means providing services critical to health and human safety. Subject: Fire Assessment Fees

Dear Mayor Hanrahan and the City of Gainesville Commissioners,

The inclusion of non-profit organizations, including religious institutions in the proposed fire assessment fees is of great concern for several reasons.

First, it violates the long established principle of tax exemption based on the separation of church and state.

It also seems to ignore the severe impact of a mandatory fee on an institution that derives its funding from voluntary donations. A non- profit institution – especially churches that exist solely to provide spiritual support to all and material aid to all it can – cannot "pass on" this added expense to its "customers" as businesses can do. You are exempting governmental units (appropriately in our opinion) even though they can pass on the costs by charging their customers user fees and taxes.

For Non-profits, including churches, this added cost will come out of already shrinking budgets. Church donations are based on expendable giving. As the cost of living, including taxes, increases our collections are among the first to decline. The churches also provide many services to the community that would otherwise go un-provided or done so at additional cost to the community. As an example; First United Methodist Church hosts a weekly free clinic, "Helping Hands", to the homeless and semi-homeless. We provide special "Family Dinners" for the homeless at holidays and even a Super Bowl Party. We donate hundreds of food boxes to community food programs. We have programs for youth. We host and support Boy and Girl Scout Troops. We provide food and social programs for the elderly. We regularly host homeless families providing housing, meals and supportive services through the Interfaith Hospitality Network. We provide space for several non-religious community organizations. We provide financial and supportive services to many individuals who come to our door. Again, all of this from free-will donations at no cost to the community. Those are the services which are most likely to be cut and handed to the City government to support or let die.

There is also the question of fairness. You are already charging each of our member families \$30 through the residential fee. Then you charge us an additional fee because we are church members.

Assistant City Manager Paul Folkers said it is appropriate for these institutions (non-profit) to pay the assessment because the fee is based on the number of services provided and there is a high demand for service calls at institutions. As the proposed fee is for fire services, we question the accuracy of that statement. On June 23, 2008, the Gainesville City Commission received an update on the status of the City's negotiations with the University of Florida seeking compensation for the continuing provision of fire services. A copy of the agenda item and back-up material is attached.

The City Commission has adopted an enabling ordinance and proposed a special assessment for fire services on improved property in the City to provide dedicated funding for this core City service. A special assessment would insulate fire services from substantial budget reductions and allow the City to maintain and selectively enhance fire services to address community needs. A special assessment must provide a benefit to property and be fairly and reasonably apportioned among the properties receiving benefit. The fire assessment would be imposed on property owned by tax exempt non-profit entities such as places of religious assembly.

The City Commission and I seek your assistance in resolving a community problem. The City has provided fire services to the University for many years without compensation. The City could not in good conscience impose a special assessment on our residents, businesses and non-profit organizations without pursuing reimbursement from the University as one of the largest beneficiaries of the City's fire services. As you know, there are other public universities in our state that do pay such fees.

We propose entering into an agreement with the University providing for an annual fire fee that would compensate the City for the value of fire services provided. This value has been determined by the City's consultant using the same data and methodology used to develop the fire assessment rates for the City. The total value of fire services provided to the University was identified as \$2,911,255. The City Commission requested that I send you the attached proposal as the basis of an agreement for a fire fee. The proposal provides for a phase-in of the fee over a period of four years in acknowledgment of the financial challenges facing the University.

I can assure you that the City Commission and I are very concerned about current budget reductions at the University. These reductions negatively impact the University and the City in many ways. Although the timing could be better, this issue does require immediate attention. We believe a reasonable agreement can be reached if the University concurs that reimbursing the City for the fire services it receives is a fair and appropriate course of action. We are eager to work jointly with you to make the case to key decision makers at the state level that there is a need for the University to make efforts to address this critical need.

We appreciate your attention to this matter and look forward to hearing from you.
