**FOURTH AMENDMENT TO THE CONTRACT FOR  
OPENING/CLOSING/CLEANING OF NATURE OPERATIONS FACILITIES**

THIS AMENDMENT is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2012 by THE CITY OF GAINESVILLE, FLORIDA, a municipal corporation (“CITY”), and SUPERGLO CLEANING SERVICES, INC., (“CONTRACTOR”).

WHEREAS, the CITY and CONTRACTOR have previously entered into an agreement for the provision of labor, equipment, materials and supervision of the opening, closing and cleaning of the CITY’S Nature Operations Facilities dated October 1 2010, first amendment dated October 1, 2011, second amendment dated December 19, 2011 and third amendment dated January 26, 2012 and

WHEREAS, the CITY and CONTRACTOR desire to amend the agreement;

NOW, THEREFORE, the parties agree as follows:

1. To provide services at **Fred Cone Park** as described herein:
  - a. Restrooms will be cleaned once a day (7 days a week)
  - b. Litter picked daily from entire grounds
  - c. Bathroom doors shall be closed and locked according to park hours
  - d. All paper products for restrooms shall be provided by contractor
  
2. To provide services at **Hogtown Creek Headwaters Nature Park** as described herein:
  - a. Unlock and open the park gate off of NW 45<sup>th</sup> Avenue by 7:00 a.m. each day MONDAY THROUGH SUNDAY. Secure the gate open to prevent driveway blockage during park operating hours.
  - b. Unlock the doors to the restrooms by 7:05 a.m. each day MONDAY THROUGH SUNDAY.
  - c. Close and lock the park gate each day MONDAY THROUGH SUNDAY:  
After 8:00 p.m. and before 9:30 p.m. from MAY 1 THROUGH OCTOBER 31  
After 6:00 p.m. and before 7:30 p.m. from NOVEMBER 1 THROUGH APRIL 30
  - d. Clean the restroom and lock the doors to the restroom as part of closing the park each day MONDAY THROUGH SUNDAY.
  - e. There is one outdoor restroom building at this facility with one women’s stall and one men’s stall. The supply closet is in the back of the building between the two stalls and a key will be provided to the Contractor. This facility’s restroom will be mopped with a sponge head mop.
  
3. The monthly cost of service at Fred Cone Park is \$650.00 (yearly is \$7,800.00). The monthly cost of service at Hogtown Creek Headwaters Nature Park is \$450.00 (yearly is \$5,400.00).

CONTRACTOR will continue to provide the services described in the agreement dated October 1, 2010 and all associated amendments, during the period of August 1, 2012 through September 30, 2012, subject to the same terms and conditions.

This amendment, when executed, together with the original contract and all associated amendments, constitute the entire contract between the parties.
