The compensation and payment set forth in this Section 6(b) is contingent upon Employer's continued use of EZLink for enrollment and contribution processing over the term of the Agreement and further contingent upon Employer not obtaining plan administration and investment advisory services for the Plan from anyone other than the existing plan administrators and/or assignees during the term of this Agreement.

#### **SECOND**

Section 9 of the Agreement, titled "Term" is amended to provide as follows:

This Agreement shall be in effect for an initial term beginning on the Execution Date and ending 5 years after the Execution Date. This Agreement will be renewed automatically for each succeeding year unless written notice of termination is provided by either party to the other no less than 60 days before the end of such Agreement year.
