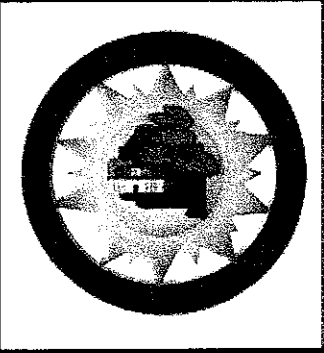
Tax Parcel Number 07176-020-000 recognized by the Alachua County Property Appraiser, being more accurately defined on the attached map.
