DISCUSSION OF PENDING REFERRALS

090872. Infrastructure Needs and Economic Development Referral to the EDUCC (B)

The Economic Development University/Community Committee heard staff, Erik Bredfeldt, Director of Planning and Development Services, give a brief introduction and overview of the pending referral.

Chair Wells, Commissioner Poe and Commissioner Donovan spoke to the matter and then called upon the community partners present to comment on community infrastructure needs which impact Innovation Gainesville and the City's Economic Development.

Partners who spoke to the matter are: Ed Poppell, Vice President BA, University of Florida Susan Crowley, Assistant VP - Community Relations, University of Florida Dug Jones, JD, Assistant VP, Santa Fe College Brent Christensen, President and CEO, Gainesville Area Chamber of Commerce Linda Reinhardt, University of Florida

Staff who spoke to the matter is: Russ Blackburn, City Manager Anthony Lyons, Director, CRA Kelly Fisher, Project Coordinator, CRA Erik Bredfeldt, Director, Planning and Development Services

In an effort to move this item forward, the Economic Development University Community Committee determined we need to identify our infrastructure deficits and how to quantify each to reach prioritized goals.

Russ Blackburn, City Manager, suggested to start with asking some key players coming from Innovation Gainesville to identify what do we think are the key aspects of Economic Development that needs to be in place. And from those issues that can come back to you and then everybody can add to that. Ultimately, you want to get to if you say that the City can only control the City streets essentially. But if we say that our level of service for streets in the City, to be successful at Economic Development, should be at 80% at C or better and if we measure that 80% is a D, then that tells us that we ought to be trying to channel resources at some point to bring those street where we can get another 10% up to a C level. So then, you begin to quantify what vou are trying to achieve from an Economic Development perspective. If we identify one of the key elements of Economic Development is available financial capital, then what does that mean? Do we think that we would absorb in a year 10 million dollars in financial capital? And how much is available in our community? So, there is a gap because there is a million dollars available in financial capital. How do we bridge that gap? I suggest that the first step is having some key players at this meeting come up with what they think are the key Economic Development inputs and bring those back to you and let everybody as a collaboration add to those. Then we can consider, are you right, or did you miss something, or here is something we hadn't thought about. And as a sub sequential step in trying to get to the answer to the question is: What is our Economic Development infrastructure?

The EDUCC directed staff to meet with community partners to identify critical Economic Development impact elements and prioritize a list of what we think the City can do and bring back that task product to the next meeting.

RECOMMENDATION

The Economic Development Committee hear a follow-up presentation by Staff to discuss coordinated provisions of Infrastructure within the community.
